# **SUMMARY**

## Synopsis of SRC Amendment

The Senate Rules Committee amendment of Senate Memorial 21 adds three phases underlined here including: those that have a right to vote must own property within the <u>benefited area</u> of the district; the task force reports its findings to the Board of the Middle Rio Grande Conservancy District <u>for its consideration and comment</u>; and also to the board of directors <u>for its consideration and comment</u>, thence to the governor.

## Synopsis of Original Bill

Senate Memorial 21 requests the Middle Rio Grande Conservancy District ("District") Board of Directors to convene a task force to study different components of the district's electoral process. This task force would be composed of 19 members representing different interests in the Conservancy. The task force would report its preliminary findings and recommendations to the Board of Directors no later than April 15, 2010 and its final findings and recommendations to the Board of Directors, the Governor, and the appropriate legislative interim committee by December 15, 2010.

# **SIGNIFICANT ISSUES**

Indian Affairs Department indicated as follows:

SM 21 requests the District Board of Directors establish a task force to study their electoral process in effort to improve voter involvement, voter education, transparency and credibility in District elections. The task force would look at a number of factors including constitutional issues concerning the limitation of the right to vote to property owners, procedures for reporting campaign contributions and expenditures, and ways to improve voter turnout and voter participation.

The memorial outlines the composition of the task force to represent different interests in the District; notably, the task force includes one representative from each of the six Indian Pueblos containing land within the district and one representative from the Six Middle Rio Grande Pueblos Water Coalition. The Pueblos of Cochiti, Santo Domingo, San Felipe, Santa Ana, Sandia, and Isleta all have land within the boundaries of the District.
