22	WHEREAS, estimates of developable solar resources along
23	the interstate 10 corridor in southwestern New Mexico exceed
24	five thousand megawatts; and
25	WHEREAS, few of these resources will be developed for

export to markets and customers without substantial new 2 transmission infrastructure; and

WHEREAS, the SunZia southwest transmission project represents such necessary transmission infrastructure and is in the process of receiving an environmental impact statement; and

WHEREAS, the bureau of land management is acting as the lead federal agency conducting the environmental impact statement for the SunZia southwest transmission project; and

WHEREAS, the bureau of land management has conducted twelve public meetings, eight of which were in New Mexico, to describe the proposed project and obtain input from the public; and

WHEREAS, the department of defense has opposed all alternative alignments in New Mexico proposed in the environmental impact statement, including alternatives with reasonable and feasible mitigation to military objections; and

WHEREAS, the development of New Mexico's renewable energy resources for export to markets and customers is a matter of economic policy that is crucial to the future of the state; and

WHEREAS, the development is consistent with the national policy of reducing the nation's dependence on foreign energy while lessening production of greenhouse gases; and

WHEREAS, the legislature supports the purpose of and need for the SunZia southwest transmission project; and

WHEREAS, both the essential mission of the military and .181688.1
