A MEMORIAL

REQUESTING THAT THE DEPARTMENT OF HEALTH ESTABLISH A TASK FORCE TO ASSESS THE BENEFITS OF UTILIZING MY COMMUNITY NM AS THE STATE'S COMPREHENSIVE, BILINGUAL INVENTORY OF RESOURCES FOR UNDERSERVED NEW MEXICANS.

WHEREAS, many New Mexico organizations maintain resource inventories to serve their constituencies; and

WHEREAS, the multiple efforts to collect and maintain resource information is costly in dollars and staff time; and

WHEREAS, duplicative efforts have produced many underfunded, incomplete and out-of-date inventories; and

WHEREAS, My Community NM is the state's only bilingual, interagency, on-line resource inventory; and

WHEREAS, My Community NM has been developed by a number of nonprofit organizations to reduce the cost and improve the

2 constituencies; and

3 WHEREAS, My Community NM currently serves a wide range of  
4 nonprofit organizations providing services to New Mexicans,  
5 including four community health councils funded by the  
6 department of health, the office of the governor's council on  
7 women's health, the New Mexico coalition to end homelessness,  
8 the Kiwanis club of Albuquerque, the university of New Mexico  
9 health sciences center office of community affairs and pathways  
10 program, la plaza de encuentro and la comunidad habla; and

11 WHEREAS, My Community NM has resulted in a cost-effective,  
12 flexible, consumer-friendly system that is accessible to  
13 English- and Spanish-speakers with very limited computer  
14 literacy skills; and

15 WHEREAS, My Community NM collects the wide range of  
16 resource information needed by at-risk New Mexicans, including  
17 health, social services, food, income support, transportation,  
18 legal, education and job-training resources; and

19 WHEREAS, the department of health currently supports a  
20 number of community initiatives, such as county- and tribal-  
21 based community health planning councils, which have the task  
22 of collecting and distributing resource information that  
23 at-risk New Mexicans need; and

24 WHEREAS, My Community NM can be used by individual  
25 community members and by members of the health care delivery

2 representatives; and *promotoras*, who help underserved  
3 individuals and families identify and access health and human

5 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
6 REPRESENTATIVES OF THE STATE OF NEW MEXICO that the department  
7 of health be requested to establish a task force to assess the  
8 benefits of the possibility of using My Community NM as the  
9 state's comprehensive, bilingual inventory of resources for  
10 underserved New Mexicans; and

11 BE IT FURTHER RESOLVED that the task force include  
12 representatives from the following organizations: the  
13 children, youth and families department; the Indian affairs  
14 department; the office of the governor's council on women's  
15 health; the New Mexico coalition to end homelessness; the  
16 Bernalillo county community health council youth coalition  
17 initiative; the Bernalillo county community health council; the  
18 children's cabinet; la comunidad habla; the Kiwanis club of  
19 Albuquerque; la plaza de encuentro; the Sandoval county  
20 community health alliance; the Sierra health council; southwest  
21 creations collaborative; the university of New Mexico health  
22 sciences center office of community affairs and pathways  
23 program; and the Valencia community partnership; and

24 BE IT FURTHER RESOLVED that the task force be requested to  
25 assess the potential of My Community NM in the following
