WHEREAS, Cibola county owns Cibola general hospital; and

WHEREAS, the Cibola county commission entered into a cooperative agreement with the Cibola general hospital corporation that expires in December 2014; and

WHEREAS, under the cooperative agreement, the role of the Cibola general hospital corporation is to manage the day-to-day operations of the hospital; and

WHEREAS, under the cooperative agreement, the role of the Cibola county commission is to oversee the management and ensure the successful operation of the hospital on behalf of

2 WHEREAS, Cibola general hospital is the primary health  
3 care provider, serving forty-five percent of Cibola county  
4 residents and serving clients and patients in the wide  
5 geographic and primarily rural areas of Cibola and McKinley  
6 counties; and

7 WHEREAS, the hospital provides one hundred fifty-five jobs  
8 and is significant to the general economic and physical well-  
9 being of residents in Cibola county and surrounding areas; and

10 WHEREAS, members of the Cibola county commission, as  
11 elected officials of Cibola county, provide a public service  
12 that advances the economic and physical well-being of the  
13 residents of Cibola county; and

14 WHEREAS, it is critical that the Cibola county commission  
15 and the Cibola general hospital corporation continue to  
16 collaborate to ensure the continued successful operation and  
17 ongoing development of the hospital for the benefit of the  
18 broadening community that it serves;

19 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE  
20 OF NEW MEXICO that the importance of the cooperative roles of  
21 both the Cibola county commission and the Cibola general  
22 hospital corporation in ensuring the uninterrupted and ongoing  
23 successful operation of Cibola general hospital for the benefit
