14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	SECTION 1. Section 4-48B-12 NMSA 1978 (being Laws 1981,
16	Chapter 83, Section 12, as amended) is amended to read:
17	"4-48B-12. TAX LEVIES AUTHORIZED
18	A. Except as provided in Subsection F of this
19	section, the county commissioners are authorized to impose a
20	mill levy and collect annual assessments against the net
21	taxable value of the property in a county to pay the cost of
22	operating and maintaining county hospitals or to pay to
23	contracting hospitals in accordance with a health care
24	facilities contract and in class A counties to pay for the
25	county's transfer to the county-supported medicaid fund

pursuant to Section 27-10-4 NMSA 1978 as follows:

2 (1)in class A counties as defined in Section 4-44-1 NMSA 1978, the mill levy shall not exceed a rate of six 3 dollars fifty cents (\$6.50), or any lower maximum amount 4 required by operation of the rate limitation provisions of 5 Section 7-37-7.1 NMSA 1978 upon a mill levy imposed pursuant to 6 7 this paragraph, on each one thousand dollars (\$1,000) of net taxable value of property allocated to the county; however, if 8 9 the county uses any portion, not to exceed one dollar fifty cents (\$1.50), of the rate authorized by this paragraph to meet 10 the requirement of Section 27-10-4 NMSA 1978, the provisions of 11 12 Section 7-37-7.1 NMSA 1978 do not apply to the portion of the rate necessary to produce the revenues required, provided that 13 the portion of the rate does not exceed one dollar fifty cents 14 (\$1.50); and 15

(2) in other counties, the mill levy shall not exceed four dollars twenty-five cents (\$4.25), or any lower maximum amount required by operation of the rate limitation provisions of Section 7-37-7.1 NMSA 1978 upon a mill levy imposed pursuant to this paragraph, on each one thousand dollars (\$1,000) of net taxable value of property allocated to the county.

B. The mill levies provided in Paragraphs (1) and (2) of Subsection A of this section shall be made at the direction of the county commissioners, but only to the extent .183358.3

that the county commissioners deem it necessary to operate and maintain county hospitals, to pay the amounts required in the performance of any health care facilities contracts made pursuant to the Hospital Funding Act and to provide for a class A county's transfer to the county-supported medicaid fund pursuant to Section 27-10-4 NMSA 1978.

C. In the event that the mill levy provided for in Paragraph (1) of Subsection A of this section is not authorized by the electorate or the resulting mill levy proceeds are not remitted to the entity operating the hospital within a reasonable time period, any lease for operation of the hospital between a county and a state educational institution named in Article 12, Section 11 of the constitution of New Mexico may, at the option of the state educational institution, be terminated immediately. Except as provided in Subsection D of this section, in the event that the mill levy provided for in Paragraph (1) of Subsection A of this section is authorized, an amount not less than the amount that would be produced by a mill levy at the rate of four dollars (\$4.00), or any lower amount that would be required by operation of the rate limitation provisions of Section 7-37-7.1 NMSA 1978 upon this rate, on each one thousand dollars (\$1,000) of net taxable value of property allocated to the county shall be provided from the proceeds of the mill levy to the state educational institution operating the hospital for hospital purposes unless .183358.3

2 D. A class A county imposing the mill levy provided 3 for in Paragraph (1) of Subsection A of this section may enter into a mutual agreement with a state educational institution 4 named in Article 12, Section 11 of the constitution of New 5 Mexico operating the hospital permitting the transfer to the 6 7 county-supported medicaid fund by the county pursuant to Section 27-10-4 NMSA 1978 of not to exceed the amount that 8 9 would be produced by a mill levy at a rate of one dollar fifty cents (\$1.50) applied to the net taxable value of property 10 allocated to the county for the prior property tax year and 11 12 also not to exceed the amount that would be produced by imposition of the county health care gross receipts tax. 13

E. The distribution of the mill levy authorized at the rates specified in Subsection A of this section shall be made to county and contracting hospitals as authorized in the Hospital Funding Act.

F. A mill levy authorized pursuant to Paragraph (1) of Subsection A of this section in a class A county having a population of more than five hundred thousand persons according to the most recent federal decennial census shall not exceed the following percentages of the mill levy authorized in calendar year 2011 in that county:

(1) eighty-five percent by January 1, 2012; (2) sixty-five percent by January 1, 2013;
