AN ACT

RELATING TO THE SUNSET ACT; PROVIDING FOR THE SUNSET OF
ADMINISTRATIVELY ATTACHED AND ADJUNCT AGENCIES AND BOARDS,
COMMISSIONS, COUNCILS, TASK FORCES, COMMITTEES AND OTHER
MEMBERSHIP ENTITIES OF THE EXECUTIVE BRANCH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of the Sunset Act is enacted to
read:

"[NEW MATERIAL] SUNSET ACT--APPLICABILITY REQUIRED FOR ALL
ADMINISTRATIVELY ATTACHED AND ADJUNCT AGENCIES AND OTHERS.--

A. Unless explicitly exempted by the legislature,
the Sunset Act applies to every administratively attached and
adjunct agency and every board, commission, council, task
force, committee and other membership entity of the executive
branch. After July 1, 2011, the legislature shall provide for

1 sunset review in any legislation that creates an
2 administratively attached or adjunct agency or membership
3 entity.

4 B. All adjunct and administratively attached
5 agencies, boards, commissions, councils, task forces,
6 committees and similar entities that existed prior to January
7 1, 2011 and that are not otherwise provided for in this or
8 another act of the first session of the fiftieth legislature
9 shall be reviewed by the legislative finance committee in 2011
10 and 2012. The committee shall recommend to the legislature
11 termination or extension of each agency or other entity and a
12 sunset schedule for those agencies and other entities for which
13 extension is recommended."
