1 SECTION 2. Section 6-24-23 NMSA 1978 (being Laws 1995, 2 Chapter 155, Section 23, as amended) is amended to read: LOTTERY TUITION FUND CREATED--PURPOSE.--3 "6-24-23. 4 Α. The "lottery tuition fund" is created in the 5 state treasury. The fund shall be administered by the [commission on] higher education department. Earnings from 6 7 investment of the fund shall accrue to the credit of the fund. 8 Any balance in the fund at the end of any fiscal year shall 9 remain in the fund for appropriation by the legislature as 10 provided in this section. 11 Money in the lottery tuition fund is Β. 12 appropriated to the [commission on] higher education department for distribution to New Mexico's public post-secondary 13 14 educational institutions and tribal colleges to provide tuition assistance for New Mexico resident undergraduates as provided 15 by law." 16 SECTION 3. A new section of Chapter 21 NMSA 1978 is 17 18 enacted to read: 19 "[NEW MATERIAL] TRIBAL COLLEGES--LEGISLATIVE LOTTERY

A. As used in this section, "tribal college" means a tribally, federally or congressionally chartered postsecondary educational institution located in New Mexico that is accredited by the north central association of colleges and schools.

B. To the extent that funds are made available by the legislature from the lottery tuition fund, the governing bodies of tribal colleges may accept lottery tuition funds and award legislative lottery scholarships for qualified resident students attending their respective institutions. The scholarships shall be used to defray the cost of tuition at tribal colleges.

C. The legislative lottery scholarships authorized in this section shall apply only to full-time resident students who, immediately upon completion of a high school curriculum at a public or accredited private New Mexico high school or upon receiving a general education development certificate, are accepted for entrance to and attend a tribal college. Each legislative lottery scholarship shall be awarded for up to four consecutive years beginning the second semester of the recipient's first year of enrollment if the recipient maintains residency in New Mexico and maintains a grade point average of 2.5 or higher on a 4.0 scale during the first semester of fulltime enrollment.

D. The legislative lottery scholarships authorized in this section shall also apply to full-time resident students who:

(1) within one hundred twenty days of completion of a high school curriculum at a public or accredited private New Mexico high school, or of receiving a .183389.1

general education development certificate, begin service in the 2 United States armed forces; and

(2) within one hundred twenty days of 3 completion of honorable service or medical discharge from the 4 5 service are accepted for entrance to and attend a tribal college. 6

7 Ε. The higher education department shall prepare guidelines setting forth explicit student continuing 8 9 eligibility criteria and guidelines for administration of the legislative lottery scholarship program at tribal colleges. 10 Guidelines shall be distributed to the governing body of each 11 12 tribal college to enable a uniform availability of the legislative tuition scholarships. The department shall enter 13 14 into agreements with the tribal colleges that allow for financial and programmatic audits of the legislative lottery 15 scholarship program." 16

SECTION 4. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 2011.
