Α. The administrative head of the energy, minerals and natural resources department is the "secretary of energy, minerals and natural resources", who shall be appointed by the governor with the consent of the senate and who shall serve in the executive cabinet.

Β. An appointed secretary of energy, minerals and 7 natural resources shall serve and have all of the duties, responsibilities and authority of that office during the period 8 9 of time prior to final action by the senate confirming or rejecting [his] the secretary's appointment. 10

C. The secretary of energy, minerals and natural resources has every power expressly enumerated in the laws to perform the secretary's duties, whether granted to the secretary, the energy, minerals and natural resources department or any division of the department, except where authority conferred upon any division is explicitly exempt from the secretary's authority by statute."
