11	RELATING TO THE PRACTICE OF MEDICINE; AMENDING THE MEDICAL
12	PRACTICE ACT TO PROVIDE FOR THE LICENSING AND REGULATION OF
13	CERTAIN ENTITIES; IMPOSING LICENSING FEES AND OTHER
14	RESTRICTIONS; MAKING AN APPROPRIATION; DECLARING AN EMERGENCY.

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 61-6-1 NMSA 1978 (being Laws 1989,
18	Chapter 269, Section 1, as amended) is amended to read:
19	"61-6-1. SHORT TITLEPURPOSE
20	A. Chapter 61, Article 6 NMSA 1978 may be cited as
21	the "Medical Practice Act".
22	B. In the interest of the public health, safety and
23	welfare and to protect the public from the improper,
24	unprofessional, incompetent and unlawful practice of medicine,
25	it is necessary to provide laws and rules controlling the

C. The primary duties and obligations of the 4 5 medical board are to issue licenses to qualified physicians, physician assistants and anesthesiologist assistants and their 6 7 business entities, to discipline incompetent or unprofessional physicians, physician assistants or anesthesiologist assistants 8 9 and to aid in the rehabilitation of impaired physicians, physician assistants and anesthesiologist assistants for the 10 purpose of protecting the public." 11

SECTION 2. Section 61-6-6 NMSA 1978 (being Laws 1973, Chapter 361, Section 1, as amended) is amended to read:

"61-6-6. DEFINITIONS.--As used in Chapter 61, Article 6

A. "approved postgraduate training program" means a program approved by the accrediting council on graduate medical education of the American medical association or by the board;

B. "board" means the New Mexico medical board; <u>C. "business entity" means a corporation, limited</u> <u>liability company or partnership that is licensed or seeking a</u> <u>license to practice medicine pursuant to the Medical Practice</u> <u>Act:</u>

[C.] <u>D.</u> "licensed physician" means a medical doctor licensed under the Medical Practice Act to practice medicine in .184545.1

[D.] <u>E.</u> "licensee" means a medical doctor, physician assistant, polysomnographic technologist or anesthesiologist assistant licensed by the board to practice in New Mexico;

[E.] <u>F.</u> "medical college or school in good standing" means a board-approved medical college or school that has as high a standard as that required by the association of American medical colleges and the council on medical education of the American medical association;

[F.] <u>G.</u> "medical student" means a student enrolled in a board-approved medical college or school in good standing;

H. "person" means an individual;

[G.] I. "physician assistant" means a health professional who is licensed by the board to practice as a physician assistant and who provides services to patients under the supervision and direction of a licensed physician;

[H.] J. "intern" means a first-year postgraduate student upon whom a degree of doctor of medicine and surgery or equivalent degree has been conferred by a medical college or school in good standing;

(1) the rendering of a written or otherwise documented medical opinion concerning diagnosis or treatment of a patient within this state by a physician located outside this state as a result of transmission of individual patient data by electronic, telephonic or other means from within this state to the physician or the physician's agent; or

(2) the rendering of treatment to a patient within this state by a physician located outside this state as a result of transmission of individual patient data by electronic, telephonic or other means from within this state to the physician or the physician's agent;

[L.] N. "sexual contact" means touching the primary genital area, groin, anus, buttocks or breast of a patient or allowing a patient to touch another's primary genital area, groin, anus, buttocks or breast in a manner that is commonly recognized as outside the scope of acceptable medical practice;

B. All fees are nonrefundable and shall be used by the board to carry out its duties efficiently."

SECTION 4. Section 61-6-26 NMSA 1978 (being Laws 1989, Chapter 269, Section 22, as amended) is amended to read:

"61-6-26. TRIENNIAL RENEWAL FEES--PENALTY FOR FAILURE TO RENEW LICENSE.--

A. On or before July 1 of every third year, every licensed physician <u>and licensed business entity</u> in this state shall apply for a certificate of triennial renewal of license for the ensuing three years. The fact that a licensed physician <u>or business entity</u> has not received a renewal form from the board shall not relieve the physician <u>or business</u> <u>entity</u> of the duty to renew the license, and the omission by the board shall not operate to exempt the physician <u>or business</u> <u>entity</u> from the penalties provided by Chapter 61, Article 6 NMSA 1978 for failure to renew [<u>his</u>] <u>a</u> license.

B. All licensed physicians <u>and business entities</u> shall pay a triennial renewal fee and impaired physicians fee as provided in Section 61-6-19 NMSA 1978 and shall return the .184545.1

1 completed renewal form together with the renewal fee and other 2 required documentation.

C. Each application for triennial renewal of license shall state the licensed physician's <u>and business</u> <u>entity's</u> full name, business address, license number and date and all other information requested by the board.

D. A licensed physician who, <u>or business entity</u> <u>that</u>, fails to submit [his] <u>the</u> application for triennial renewal on or before July 1 but who submits [his] <u>the</u> application for triennial renewal by August 15 shall be assessed a late fee as provided in Section 61-6-19 NMSA 1978.

E. A <u>licensed</u> physician who, <u>or business entity</u> <u>that</u>, submits the application for triennial renewal between August 16 and September 30 shall be assessed a cumulative late fee as provided in Paragraph (6) of Subsection A of Section 61-6-19 NMSA 1978.

F. After September 30, the board may, in its discretion, summarily suspend for nonpayment of fees the license of a physician who, <u>or business entity that</u>, has failed to renew [his] the physician's or business entity's license."

SECTION 5. Section 61-6-27 NMSA 1978 (being Laws 1945, Chapter 74, Section 2, as amended) is amended to read:

"61-6-27. ISSUANCE AND DISPLAY OF RENEWAL CERTIFICATE.--The board shall issue to each licensed physician, or business entity upon application in accordance with the .184545.1 - 10 -

1 provisions of the Medical Practice Act and upon payment of the 2 appropriate fees and, in the case of a licensed physician, upon 3 documentation of continuing education requirements, a certificate of triennial renewal, under the seal of the board, 4 for the ensuing three years. The certificate of renewal shall 5 contain the licensed physician's or business entity's name, 6 7 business address, license date and number and other information as the board deems advisable.
