11	RELATING TO PUBLIC RECORDS; REQUIRING A CUSTODIAN OF PUBLIC
12	RECORDS TO CERTIFY THAT THE RECORDS PRODUCED ARE TRUE AND
13	CORRECT COPIES AND MADE IN THE REGULAR COURSE OF THE OPERATIONS
14	OF THE PUBLIC BODY OR THAT NO SUCH RECORDS EXIST; REQUIRING THE
15	CUSTODIAN TO IDENTIFY THE REQUEST WHEN RESPONDING; AMENDING A
16	SECTION OF THE INSPECTION OF PUBLIC RECORDS ACT.

18	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
19	SECTION 1. Section 14-2-7 NMSA 1978 (being Laws 1993,
20	Chapter 258, Section 4, as amended) is amended to read:
21	"14-2-7. DESIGNATION OF CUSTODIANDUTIES
22	A. Each public body shall designate at least one
23	custodian of public records who shall:
24	$[A_{\bullet}]$ (1) receive and respond to requests to
25	inspect public records;

1	$[B_{\cdot}]$ (2) provide proper and reasonable
2	opportunities to inspect public records;
3	[C.] <u>(3)</u> provide reasonable facilities to make
4	or furnish copies of the public records during usual business

6	$[\underline{P_{\cdot}}]$ (4) post in a conspicuous location at the
7	administrative office of each public body a notice describing:
8	[(1)] (a) the right of a person to
9	inspect a public body's records;
10	[(2)] <u>(b)</u> procedures for requesting
11	inspection of public records;
12	[(3)] <u>(c)</u> procedures for requesting
13	copies of public records;
14	[(4)] <u>(d)</u> reasonable fees for copying
15	public records; and
16	[(5)] <u>(e)</u> the responsibility of a public
17	body to make available public records for inspection.
18	B. When producing public records, a custodian shall
19	set forth the request and identify the documents responsive to
20	the request. The custodian shall, upon request, certify that
21	the records produced are:
22	(1) true and correct copies; and
23	(2) made in the regular course of the
24	operations of the public body.
