Mr. President:

Your **JUDICIARY COMMITTEE**, to whom has been referred

SENATE BILL 134, as amended

has had it under consideration and reports same with recommendation that it **DO PASS**, amended as follows:

1. Strike Senate Public Affairs Committee Amendment 2.
 2. On page 1, line 13, after "CANNABINOIDS", insert "AND CERTAIN OTHER SYNTHETIC DRUGS".
 3. On page 5, line 19, strike "and".
 4. On page 6, between lines 12 and 13, insert the following:
 - (i) 1-pentyl-3-(4-chloro naphthoyl)indole;
 - (j) (2-methyl-1-propyl-1H-indol-3-yl)-1-naphthalenyl-methanone; and
 - (k) 5-(1,1-dimethylheptyl)-2-(3-hydroxy cyclohexyl)-phenol;
- (20) 3,4-methylenedioxymethcathinone;
 - (21) 3,4-methylenedioxypropylvalerone;
 - (22) 4-methylmethcathinone;
 - (23) 4-methoxymethcathinone;
 - (24) 3-fluoromethcathinone; and
 - (25) 4-fluoromethcathinone;"

5. On page 14, between lines 1 and 2, insert the following new subsection:

"C. A minor who violates this section with respect to synthetic cannabinoids or any of the substances listed in Paragraphs (20) through (25) of Subsection C of Section 30-31-6 NMSA 1978 is guilty of a petty misdemeanor and, notwithstanding the provisions of Sections 32A-1-5 and 32A-2-19 NMSA 1978, shall be punished by a fine not to exceed one hundred dollars (\$100) or forty-eight hours of community service. For the third or subsequent violation by a minor of this section with respect to synthetic cannabinoids or any of the substances listed in Paragraphs (20) through (25) of Subsection C of Section 30-31-6 NMSA 1978, the provisions of Section 32A-2-19 NMSA 1978 shall govern punishment of the minor. As used in this subsection, "minor" means a person who is less than eighteen years of age."

6. Reletter the succeeding subsections accordingly.

7. On page 14, line 2, strike "D" and insert in lieu thereof "E".

8. On page 15, line 14, strike "A" and insert in lieu thereof "Except for a minor as defined in Subsection C of this section, a".
