11	RELATING TO PUBLIC EMPLOYEE RETIREMENT; AMENDING THE PUBLIC
12	EMPLOYEES RETIREMENT ACT TO PROVIDE THAT RETIRED STATE POLICE
13	MEMBERS MAY BE HIRED AS UNDERSHERIFFS OR DEPUTY SHERIFFS
14	WITHOUT SUSPENDING THEIR PENSIONS.

16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 10-11-8 NMSA 1978 (being Laws 1987,
18	Chapter 253, Section 8, as amended) is amended to read:
19	"10-11-8. NORMAL RETIREMENTRETURN TO EMPLOYMENT
20	BENEFITS CONTINUEDEMPLOYER CONTRIBUTIONS
21	A. A member may retire upon fulfilling the
22	following requirements prior to the selected date of
23	retirement:
24	(1) a written application for normal
25	retirement, in the form prescribed by the association, is filed

1 with the association;

2 (2) employment is terminated with all
3 employers covered by any state system or the educational
4 retirement system;

5 (3) the member selects an effective date of
6 retirement that is the first day of a calendar month; and
7 (4) the member meets the age and service
8 credit requirement for normal retirement specified in the
9 coverage plan applicable to the member.

B. The amount of normal retirement pension is
determined in accordance with the coverage plan applicable to
the member.

C. Except as provided in Subsection D of this section, on or after July 1, 2010, a retired member may be subsequently employed by an affiliated public employer only pursuant to the following provisions:

(1) the retired member has not been employed as an employee of an affiliated public employer or retained as an independent contractor by the affiliated public employer from which the retired member retired for at least twelve consecutive months from the date of retirement to the commencement of employment or reemployment with an affiliated public employer;

(2) the retired member's pension shall be suspended upon commencement of the employment;

1	(3) except as provided in Subsection F of this
2	section, the previously retired member shall not become a
3	member and thus the previously retired member shall accrue no
4	service credit and the previously retired member and that
5	person's affiliated public employer shall make no contributions
6	under any coverage plan pursuant to the Public Employees

8	(4) upon termination of the subsequent
9	employment, the previously retired member's pension shall

12	D. The provisions of Subsection C of this section

during retirement pursuant to Subsection D of this section is entitled to receive retirement benefits but is not entitled to accrue service credit or to acquire or purchase service credit in the future for the period of the previously retired member's reemployment with an affiliated public employer.

F. At any time during a previously retired member's subsequent employment pursuant to Subsection C of this section, the previously retired member may elect to become a member and the following conditions shall apply:

(1) the previously retired member and the subsequent affiliated public employer shall make the required employee and employer contributions, and the previously retired member shall accrue service credit for the period of subsequent employment; and

(2) when the previously retired member terminates the subsequent employment with an affiliated public employer, the previously retired member shall retire according to the provisions of the Public Employees Retirement Act, subject to the following conditions:

(a) payment of the pension shall resumein accordance with the provisions of Subsection A of thissection;

(b) unless the previously retired member accrued at least three years of service credit on account of the subsequent employment, the recalculation of pension shall: .184209.1

1) employ the form of payment selected by the previously
retired member at the time of the first retirement; and 2) use
the provisions of the coverage plan applicable to the member on
the date of the first retirement; and

(c) the recalculated pension shall not be less than the amount of the suspended pension.

G. A previously retired member who returned to work with an affiliated public employer prior to July 1, 2010 shall be subject to the provisions of this section in effect on the date the previously retired member returned to work; provided that, on and after July 1, 2010, the previously retired member shall pay the employee contribution in an amount specified in the Public Employees Retirement Act for the position in which the previously retired member is employed.

H. The pension of a member who has three or more years of service credit under each of two or more coverage plans shall be determined in accordance with the coverage plan that produces the highest pension. The pension of a member who has service credit under two or more coverage plans but who has three or more years of service credit under only one of those coverage plans shall be determined in accordance with the coverage plan in which the member has three or more years of service credit. If the service credit is acquired under two different coverage plans applied to the same affiliated public employer as a consequence of an election by the members,

1 adoption by the affiliated public employer or a change in the 2 law that results in the application of a coverage plan with a 3 greater pension, the greater pension shall be paid a member retiring from the affiliated public employer under which the 4 change in coverage plan took place regardless of the amount of 5 service credit under the coverage plan producing the greater 6 7 pension; provided the member has three or more years of 8 continuous employment with that affiliated public employer 9 immediately preceding or immediately preceding and immediately following the date the coverage plan changed. 10 The provisions of each coverage plan for the purpose of this subsection shall 11 12 be those in effect at the time the member ceased to be covered by the coverage plan. "Service credit", for the purposes of 13 this subsection, shall be only personal service rendered an 14 affiliated public employer and credited to the member under the 15 provisions of Subsection A of Section 10-11-4 NMSA 1978. 16 Service credited under any other provision of the Public 17 Employees Retirement Act shall not be used to satisfy the 18 three-year service credit requirement of this subsection." 19
