12	CLARIFY ITS PURPOSES, REVISE THE BOARD'S MEMBERSHIP AND CLARIFY

15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 24-19-2 NMSA 1978 (being Laws 1986,
17	Chapter 15, Section 2, as amended) is amended to read:
18	"24-19-2. PURPOSEIt is the purpose of the Children's
19	Trust Fund Act to:
20	A. provide the means to develop innovative
21	children's projects <u>and programs</u> that address one or more of

SECTION 3. Section 24-19-4 NMSA 1978 (being Laws 1986, Chapter 15, Section 4, as amended) is amended to read:

"24-19-4. CHILDREN'S TRUST FUND CREATED--EXPENDITURE LIMITATIONS.--

A. The "children's trust fund" is created in the state treasury. The children's trust fund may be used for any purpose enumerated in Section 24-19-2 NMSA 1978. All income received from investment of the fund shall be credited to the fund. No money appropriated to the fund or otherwise accruing to it shall be disbursed in any manner except as provided in the Children's Trust Fund Act.

B. The children's trust fund shall be administered by the department for the purpose of funding children's projects <u>and programs</u> from the income received from investment of the fund; provided that none of the income shall be used for capital expenditures. All income from investment of the fund is appropriated to the department for that purpose or for administrative costs as provided in Subsection C of this section. Grants, distributions and transfers of money from the fund shall be made only from the income received from investment of the fund.

C. Up to ten percent of the income received from investment of the children's trust fund may be expended for .185155.1

costs of administration of the fund and administration of the children's projects <u>and programs</u> undertaken with fund money. Administrative costs include per diem and mileage, staff salaries and expenses related to administration of the fund.

D. Disbursements from income credited to the children's trust fund and appropriated to the department shall be made only upon warrants drawn by the secretary of finance and administration pursuant to vouchers signed by the secretary of children, youth and families or the secretary's designated representative to fund children's projects <u>and programs</u> approved by the board.

E. One-half of the money transferred to the children's trust fund pursuant to Section 40-1-11 NMSA 1978, [and] all of the money transferred to the children's trust fund pursuant to Section 66-3-420 NMSA 1978 and all of the money received from federal funds or grants and donations or bequests from private sources as provided for in Section 24-19-9 NMSA 1978 shall be deemed income received from investment of the fund."

SECTION 4. Section 24-19-5 NMSA 1978 (being Laws 1986, Chapter 15, Section 5, as amended) is amended to read:

"24-19-5. CHILDREN'S TRUST FUND BOARD OF TRUSTEES CREATED--MEMBERS.--

A. There is created the "children's trust fund board of trustees" consisting of [nine] <u>thirteen</u> members, not .185155.1

1 employees of the state, knowledgeable in the area of children's 2 programs and representative of multiple, diverse perspectives within the state, who shall be appointed by the governor with 3 the advice and consent of the senate. No more than seven of 4 the members shall be from the same political party. Of these 5 members, at least two shall be individuals of recognized 6 7 standing in the field of children's services. On the initial board, two members shall be appointed for terms ending on July 8 9 1, 1988; two members shall be appointed for terms ending on July 1, 1989; and three members shall be appointed for terms 10 ending on July 1, 1990. Thereafter, appointments shall be made 11 12 for terms of four years. Vacancies of appointed members shall be filled by appointment by the governor for the unexpired 13 14 term.

B. The board shall select a person from its membership to serve as [<del>chairman</del>] <u>chair</u>."

SECTION 5. Section 24-19-7 NMSA 1978 (being Laws 1986, Chapter 15, Section 7, as amended) is amended to read:

"24-19-7. DUTIES OF THE BOARD.--At least four times a year, the board shall meet upon the call of its [chairman] <u>chair</u> to [review proposals submitted to the department by <u>public or private entities and</u>] take all action necessary or proper for the administration of the Children's Trust Fund Act. The board shall <u>also</u> approve or disapprove [each proposal] <u>all</u> <u>proposals</u> submitted and shall base its decision on the

All income received from investment of the fund shall be credited to the fund. No money appropriated to the fund or otherwise accruing to it shall be disbursed in any manner except as provided in the Children's Trust Fund Act.

B. The fund shall be used to fund next generation
fund projects <u>and programs</u> that are approved by the board.
Next generation fund projects <u>and programs</u> shall:

(1) provide positive child and youth
 development activities that support physical, mental and social
 well-being;

(2) promote strong, healthy families and help to prevent child abuse and neglect;

C. The next generation fund shall be administered by the department, and the income from investment of the fund is appropriated to the department to carry out the purposes of the fund. None of the income shall be used for capital expenditures. Grants, distributions and transfers of money from the fund shall be made only from the income received from investment of the fund.

D. Up to ten percent of the income received from investment of the fund may be expended for costs of administering the fund and next generation projects <u>and</u> <u>programs</u>. Administrative costs include per diem and mileage, staff salaries and expenses related to administration of the fund.

E. Disbursements from the fund shall be made by warrants drawn by the secretary of finance and administration pursuant to vouchers signed by the secretary of children, youth and families or the secretary's designated representative."

Members serve at the pleasure of the 5 Members shall select a member to serve as [chairperson] 6 board. 7 chair of the council. Members are entitled to per diem and 8 mileage as provided in the Per Diem and Mileage Act and shall 9 receive no other compensation, perquisite or allowance. The council shall evaluate proposed next 10 Β. generation fund projects and programs and make funding 11 recommendations to the board.
