#### **SUMMARY**

## Synopsis of Bill

House Bill 180 would authorize the DGF to issue a temporary 5-day fishing and temporary 4-day small game hunting license for resident, active-duty military members. To be eligible to purchase this license, the buyer must be a "resident on active duty with the armed forces of the United States or national guard stationed outside of New Mexico and is currently on leave for thirty days or less".

### FISCAL IMPLICATIONS

The DGF states House Bill 180 would afford an opportunity that doesn't currently exist in statute. The Department estimates of the approximate 7,000 New Mexico residents that are members of the United States Military and National Guard, approximately 1,750 active-duty residents may consider purchasing one or both of these new licenses types. However, because the Department currently offers an annual discounted-fee license to active-duty military members that allows them to fish and hunt both deer and small game for \$28.00 (versus the proposed \$12.00 fishing license and \$16.00 small game license), the Department feels that many active-duty license buyers may continue to opt for the \$28.00 option. While any current buyers switching to the new discounted license would reduce revenue, we estimate that the newly available temporary licenses may bring new customers, offsetting any revenue lost to discounts. Therefore, the Department estimates the active-duty members that will purchase the temporary license is 250 annually, resulting in an estimated increase of \$7,000 to the Game Protection Fund

# **ADMINISTRATIVE IMPLICATIONS**

The DGF advises this bill would require a minor modification to the Department's current licensing programs. This license would only be available from Department Offices because of the need to provide adequate documentation of the temporary leave from active-duty.
