11	REQUESTING THE CULTURAL AFFAIRS DEPARTMENT TO CONDUCT A

15	WHEREAS, the Jemez state monument heritage area is one of
16	the most beautiful prehistoric and historic sites in the
17	southwest; and
18	WHEREAS, the Jemez state monument heritage area includes
19	the stone ruins of the village of Giusewa, a five-hundred-year-
20	old village of the Pueblo of Jemez; and
21	WHEREAS, the village of Giusewa was built over six hundred
22	years ago in the narrow San Diego canyon by the ancestors of
23	the present-day people of the Pueblo of Jemez; and
24	WHEREAS, the heritage center contains exhibitions that
25	tell the story of the site through the words of the Jemez

WHEREAS, the Jemez people built villages in the narrow mountain valley and on the tops of the steep, sculptured mesas of their ancestral homelands in the Jemez state monument heritage area; and

WHEREAS, the Pueblo of Jemez is a federally recognized Indian tribe with a sovereign government capable of administering the proper care and management of the Jemez state monument heritage area and the historic and prehistoric structures and other objects of scientific interest that are situated in that area; and

WHEREAS, the state is currently facing dire revenue shortfalls and is considering reducing the size of state government and eliminating services provided by state government; and

WHEREAS, the Jemez state monument heritage area is best left to the control, care and management of the Pueblo of Jemez;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the cultural affairs department be requested to study the feasibility and requirements for the legislature to transfer ownership and control of the lands owned or controlled by the state in the Jemez state monument heritage area to the Pueblo of Jemez and present its findings and requirements to the appropriate interim committee of the .183107.1
