10	A MEMORIAL
11	REQUESTING CONGRESS TO REAUTHORIZE THE WATER RESOURCES
12	DEVELOPMENT ACT OF 2007, SECTION 5056, AND TO APPROPRIATE
13	SUFFICIENT FUNDS TO ADDRESS SALINITY PROBLEMS ASSOCIATED WITH
14	THE PECOS RIVER.

16	WHEREAS, the Amistad international reservoir, situated on
17	the Texas-Mexico border near Del Rio, supplies water to
18	numerous area communities for municipal, industrial and
19	agricultural purposes; yet, with a salt content near the upper
20	limit of the Texas standard for drinking water, the reservoir
21	may become an unusable resource for all; and
22	WHEREAS, two of its main tributaries, the Rio Grande and
23	the Pecos river, are heavily saturated with salt due to the
24	composition of the surrounding land, which was once part of a
25	great inland sea; when dry land emerged, salt from the sea was

trapped in the soil and in underground aquifers; in particular, the Pecos river, originating in New Mexico, is one of the most saline waterways in North America and accounts for thirty percent of the salt loading of the Amistad international reservoir; and

WHEREAS, the upper limit of Texas drinking water standards for minerals, including salt, is one thousand milligrams per liter; when that limit is exceeded, municipalities that rely on water released into the Rio Grande from the Amistad international reservoir will have to devise costly treatment methods to meet state standards; moreover, the elevated levels of salt may force farmers to discontinue the growth of certain crops; while fresh water inflow from runoff could help alleviate the salinity, the potential for such runoff is limited; and

WHEREAS, the Amistad international reservoir is shared by both the United States and Mexico, in accordance with the terms of a 1944 treaty; for that reason and because the reservoir's holdings derive from multiple states, it is incumbent on the federal government to take the lead in addressing this urgent problem; and

WHEREAS, congress began that process by enacting Section 729 of the Water Resources Development Act of 1986 and by developing a program in Section 5056 of the Water Resources Development Act of 2007 that directs the secretary of the army

to rehabilitate and enhance fish and wildlife habitats and to implement long-term monitoring, data collection and analysis, applied research and adaptive management within the Rio Grande basin; and

WHEREAS, past studies must be evaluated to determine a strategy for moving forward; in addition, it is imperative that funding and continuing authority for Section 5056 of the Water Resources Development Act of 2007, which is set to expire in 2011, be reenacted so that efforts to solve the salt problem in the reservoir can continue;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that the United States congress be requested to reauthorize Section 5056 of the Water Resources Development Act of 2007 and to appropriate sufficient funds to carry out work related to that legislation; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the president of the United States, the speaker of the house of representatives and the president of the senate of the United States congress and the members of the New Mexico Congressional delegation.
