10 A JOINT MEMORIAL

11 PROCLAIMING FEBRUARY 9, 2011 TO BE "COLONIAS DAY AT THE  
12 LEGISLATURE" AND REQUESTING THE GOVERNOR AND HER CABINET TO  
13 ASSIST LOCAL EFFORTS TO IMPROVE THE QUALITY OF LIFE IN NEW  
14 MEXICO BY ADDING RURAL COMMUNITIES AND COLONIAS TO THE STATE'S  
15 PRIORITY ACTION LIST OF PROGRAMS AND WATER PROJECTS FOR  
16 LEGISLATIVE FUNDING.

18 WHEREAS, the board of directors of the New Mexico  
19 association of counties comprises the elected officials who are  
20 responsible for the health, welfare and safety of the residents  
21 of New Mexico's thirty-three counties, and these board members  
22 are asked to represent and address the needs of these  
23 residents; and

24 WHEREAS, rural and colonias communities are sorely lacking  
25 in infrastructure, accessibility, opportunities and sanitation

1 services, and, by working together, the state and individual  
2 counties could lift up these communities and provide better  
3 futures for the children in the communities who will in turn  
4 raise their own families on family properties, thereby making  
5 meaningful progress toward enhancing the most basic of human  
6 needs in these challenged communities; and

7 WHEREAS, residents of rural and colonias communities  
8 statewide face harsh challenges on a daily basis, but they are  
9 proud people who are reluctant to ask for help; and

10 WHEREAS, individual counties continue to undertake  
11 independent and ambitious infrastructure improvement plans  
12 designed to enhance social and economic development  
13 opportunities for all residents of New Mexico; and

14 WHEREAS, by initiating a statewide improvement program for  
15 rural and colonias communities, the state could partner with  
16 the thirty-three counties to empower these small communities  
17 and dramatically improve the quality of life in them, while  
18 simultaneously creating new entrepreneurial zones that will  
19 complement existing projects in incorporated municipalities;

20 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE  
21 STATE OF NEW MEXICO that February 9, 2011 be recognized as  
22 "Colonias Day at the Legislature"; and

23 BE IT FURTHER RESOLVED that Governor Martinez and her  
24 cabinet be requested to work with the board of directors of the  
25 New Mexico association of counties to assist local efforts to
