| 18 | SECTION 1. Section 33-2-34 NMSA 1978 (being Laws 1999, |
| 19 | Chapter 238, Section 1, as amended) is amended to read: |
| 20 | "33-2-34. ELIGIBILITY FOR EARNED MERITORIOUS |

| 22 | A. To earn meritorious deductions, a prisoner |
| 23 | confined in a correctional facility designated by the |
| 24 | corrections department must be an active participant in programs |
| 25 | recommended for the prisoner by the classification supervisor |

1 and approved by the warden or the warden's designee. 2 Meritorious deductions shall not exceed the following amounts: 3 (1) for a prisoner confined for committing a serious violent offense, up to a maximum of four days per month 4 5 of time served: (2) for a prisoner confined for committing a 6 7 nonviolent offense, up to a maximum of thirty days per month of time served; 8 9 (3) for a prisoner confined following revocation of parole for the alleged commission of a new felony 10 offense or for absconding from parole, up to a maximum of four 11 12 days per month of time served during the parole term following revocation; and 13 14 (4) for a prisoner confined following revocation of parole for a reason other than the alleged 15 commission of a new felony offense or absconding from parole: 16 (a) up to a maximum of eight days per 17 month of time served during the parole term following 18 revocation, if the prisoner was convicted of a serious violent 19 20 offense or failed to pass a drug test administered as a condition of parole; or 21 (b) up to a maximum of thirty days per 22 month of time served during the parole term following 23 revocation, if the prisoner was convicted of a nonviolent 24 offense. 25 .187766.1

B. A prisoner may earn meritorious deductions upon recommendation by the classification supervisor, based upon the prisoner's active participation in approved programs and the quality of the prisoner's participation in those approved programs. A prisoner may not earn meritorious deductions unless the recommendation of the classification supervisor is approved by the warden or the warden's designee.

C. If a prisoner's active participation in approved programs is interrupted by a lockdown at a correctional facility, the prisoner may continue to be awarded meritorious deductions at the rate the prisoner was earning meritorious deductions prior to the lockdown, unless the warden or the warden's designee determines that the prisoner's conduct contributed to the initiation or continuance of the lockdown.

D. A prisoner confined in a correctional facility designated by the corrections department is eligible for lumpsum meritorious deductions as follows:

(1) for successfully completing an approved vocational, substance abuse or mental health program, one month; except when the prisoner has a demonstrable physical, mental health or developmental disability that prevents the prisoner from successfully earning a general education diploma, in which case, the prisoner shall be awarded three months;

(2) for earning a general education diploma,three months;

1 (3) for earning an associate's degree, four
2 months;

(4) for earning a bachelor's degree, five

5 (5) for earning a graduate qualification, five6 months; and

for engaging in a heroic act of saving 7 (6) 8 life or property, engaging in extraordinary conduct for the 9 benefit of the state or the public that is at great expense or risk to or involves great effort on [behalf] the part of the 10 prisoner or engaging in extraordinary conduct far in excess of 11 12 normal program assignments that demonstrates the prisoner's commitment to self-rehabilitation. The classification 13 14 supervisor and the warden or the warden's designee may recommend the number of days to be awarded in each case based 15 upon the particular merits, but any award shall be determined 16 by the director of the adult institutions division of the 17 18 corrections department or the director's designee.

E. Lump-sum meritorious deductions, provided in Paragraphs (1) through (6) of Subsection D of this section, may be awarded in addition to the meritorious deductions provided in Subsections A and B of this section. Lump-sum meritorious deductions shall not exceed one year per award and shall not exceed a total of one year for all lump-sum meritorious deductions awarded in any consecutive twelve-month period. .187766.1

1 A prisoner is not eligible to earn meritorious F. 2 deductions if the prisoner: disobeys an order to perform labor, 3 (1) pursuant to Section 33-8-4 NMSA 1978; 4 is in disciplinary segregation; 5 (2) is confined for committing a serious 6 (3) 7 violent offense and is within the first sixty days of receipt by the corrections department; or 8 9 (4) is not an active participant in programs recommended and approved for the prisoner by the classification 10 supervisor. 11 12 G. The provisions of this section shall not be interpreted as providing eligibility to earn meritorious 13 deductions from a sentence of life imprisonment or a sentence 14 of [death] life imprisonment without possibility of release or 15 parole. 16 н. The corrections department shall promulgate 17 rules to implement the provisions of this section, and the 18 rules shall be matters of public record. A concise summary of 19 20 the rules shall be provided to each prisoner, and each prisoner shall receive a quarterly statement of the meritorious 21 deductions earned. 22 A New Mexico prisoner confined in a federal or I. 23 out-of-state correctional facility is eligible to earn 24 meritorious deductions for active participation in programs on 25

All decisions regarding the award and forfeiture of meritorious deductions at such facility are subject to final approval by the director of the adult institutions division of the corrections department or the director's designee.

7 J. In order to be eligible for meritorious deductions, a prisoner confined in a federal or out-of-state 8 9 correctional facility designated by the corrections department must actively participate in programs that are available. If a 10 federal or out-of-state correctional facility does not have 11 12 programs available for a prisoner, the prisoner may be awarded meritorious deductions at the rate the prisoner could have 13 14 earned meritorious deductions if the prisoner had actively participated in programs. 15

K. A prisoner confined in a correctional facility in New Mexico that is operated by a private company, pursuant to a contract with the corrections department, is eligible to earn meritorious deductions in the same manner as a prisoner confined in a state-run correctional facility. All decisions regarding the award or forfeiture of meritorious deductions at such facilities are subject to final approval by the director of the adult institutions division of the corrections department or the director's designee.

Except for sex offenders, as provided in Section Μ. 31-21-10.1 NMSA 1978, an offender sentenced to confinement in a correctional facility designated by the corrections department who has been released from confinement and who is serving a parole term may be awarded earned meritorious deductions of up to thirty days per month upon recommendation of the parole officer supervising the offender, with the final approval of the adult parole board. The offender must be in compliance with all the conditions of the offender's parole to be eligible for earned meritorious deductions. The adult parole board may remove earned meritorious deductions previously awarded if the offender later fails to comply with the conditions of the offender's parole. The corrections department and the adult parole board shall promulgate rules to implement the provisions of this subsection. This subsection applies to offenders who .187766.1
