AN ACT

RELATING TO ELECTIONS; REMOVING REQUIREMENTS THAT APPLICATIONS FOR ABSENTEE OR ABSENTEE-EARLY BALLOTS IN CERTAIN CONSERVANCY DISTRICT ELECTIONS BE NOTARIZED.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 73-14-31.1 NMSA 1978 (being Laws 1996, Chapter 42, Section 15) is amended to read:

"73-14-31.1. ABSENTEE BALLOT APPLICATION.--

A. Application by a qualified elector for an absentee ballot shall be made on the official form prescribed by the board of directors and printed and furnished by the election director. The form shall identify the applicant and contain information to establish ~~his~~ the applicant's qualification as a qualified elector for issuance of an absentee ballot. Each application for an absentee ballot shall

1 be [~~subscribed and sworn to~~] signed by the applicant.

2 B. The election director shall mark each completed
3 absentee ballot application with the date and time of receipt
4 and enter the required information in the absentee ballot
5 qualified elector list. The election director shall then
6 determine if the applicant is a qualified elector.

7 C. If the applicant is not listed in the qualified
8 elector list, an absentee ballot shall not be issued and the
9 election director shall mark the application "rejected" and
10 file the application in a separate file from those accepted.

11 D. The election director shall notify in writing
12 each applicant of the fact of acceptance or rejection of [~~his~~]
13 the applicant's application and, if rejected, shall state the
14 reason for rejection.

15 E. If the election director determines that the
16 applicant is a qualified elector, the election director shall
17 mark the application "accepted" and deliver or mail to the
18 applicant an absentee ballot and the required envelopes for use
19 in returning the ballot to the absent voter precinct."

20 SECTION 2. Section 73-14-31.3 NMSA 1978 (being Laws 1999,
21 Chapter 168, Section 8) is amended to read:

22 "73-14-31.3. ABSENTEE-EARLY VOTING--ELECTIONEERING.--

23 A. A voter may apply to vote absentee-early by
24 completing an absentee-early ballot application on the official
25 form prescribed by the board of directors and printed and

1 furnished by the election director. The form shall identify
2 the applicant and contain information to establish [~~his~~] the
3 applicant's qualifications as a qualified elector for issuance
4 of an affidavit for absentee-early voting. Each application
5 shall be [~~subscribed and sworn to~~] signed by the applicant.

6 B. Once it is determined that the application form
7 is complete, the election director shall mark the application
8 with the date and time of receipt and enter the required
9 information in the absentee ballot register.

10 C. If the voter is determined to be a qualified
11 elector, the [~~elections~~] election director shall inform the
12 voter that [~~his~~] the voter's application has been accepted and
13 instruct the voter on how to vote.

14 D. For the purpose of absentee-early voting,
15 electioneering is not permitted in the election director's
16 office, the middle Rio Grande conservancy district offices or
17 designated satellite locations.

18 E. For the purpose of this section,
19 "electioneering" means any form of campaigning within one
20 hundred feet of the election director's office, the middle Rio
21 Grande conservancy district office or designated satellite
22 locations and includes the display of signs or distribution of
23 campaign literature."

24 **SECTION 3. EFFECTIVE DATE.**--The effective date of the
25 provisions of this act is July 1, 2012.
