CAPITAL PROJECTS FOR REPRESENTATIVE LARRY A. LARRANAGA

I request that the following be funded:

- to the public education department

MONTESSORI ELEMENTARY CHARTER SCHL CARPET

one hundred thousand dollars (\$100,000) to purchase and install carpet for classrooms in the Montessori elementary charter school in Bernalillo county

SOUTHWEST PRIMARY LEARNING CENTER SMART LAB

seventy-five thousand dollars (\$75,000) to plan, design, purchase and install a smart lab, including related equipment, furniture and infrastructure, at the Southwest primary learning center in Albuquerque in Bernalillo county

- to the local government division of the department of finance and administration

ALB EASTDALE LITTLE LEAGUE COMPLEX IMPROVE

seven hundred six thousand dollars (\$706,000) to plan, design, construct, equip and improve the baseball and softball complex, including energy and safety upgrades, turf, bleachers and infrastructure, for Eastdale little league in Albuquerque in Bernalillo county

BERN CO CORRECTIONAL FACILITY CONSTRUCT

five million dollars (\$5,000,000) to design, construct and renovate an existing county-owned correctional facility in Albuquerque in Bernalillo county

MOUNTAINAIR STUDIO BUILDING PURCHASE

one hundred twenty thousand dollars (\$120,000) to purchase a building for use as a studio in Mountainair in Torrance county

PASEO DEL NORTE BLVD/I-25 INTERCHANGE

forty-six million five hundred thousand dollars (\$46,500,000) for right-of-way acquisition, planning, designing and constructing the Paseo del Norte boulevard and interstate 25 interchange, including a north-to-west flyover from interstate 25 to Paseo del Norte, an east-to-south free-flow on-ramp from Paseo del Norte to interstate 25 and a grade-separated interchange at Paseo del Norte and Jefferson boulevard, in Albuquerque in Bernalillo county

- to the board of regents of the university of New Mexico

UNM ATHLETIC FIELDS IMPROVE-CONTINGENCY

one million nine hundred thousand dollars (\$1,900,000) to plan, design and construct improvements to the athletic fields at the university of New Mexico in Albuquerque in Bernalillo county, contingent upon a joint powers agreement between the university, the Albuquerque public school district and the New Mexico activities association for shared use of the fields
