two hundred fifty thousand dollars (\$250,000) to plan, design, construct and equip bar screen, aerators and other improvements for the wastewater treatment plant in Deming in Luna county

ELEPHANT BUTTE SEWER MAIN LINE CONSTRUCT

two million three hundred thousand dollars (\$2,300,000) to design and construct a sewer main line in Elephant Butte in Sierra county
