SUMMARY

Synopsis of Bill

House Bill 168 amends Section 31-12-7 NMSA 1978, Motor Vehicles, Influence of Intoxicating Liquor or Drugs; Fee upon Conviction. The bill creates a \$50 public safety equipment fee and a new non-reverting fund, public safety equipment fund, in which to deposit the fees. The bill requires the courts to assess and collect the fee on all convictions of Section 66-8-102 NMSA 1978 or a municipal ordinance that prohibits driving while under the influence of intoxicating liquor or drugs. Balances in the fund are subject to appropriation to the department of public safety for purchase of safety equipment.

^{*} Three year estimated budget impact assumes the department could budget up to the maximum amount available.

FISCAL IMPLICATIONS

Based on the convictions included in the FY11 New Mexico Judicial Branch Annual Report Statistical Addendum, the fee could provide as much as \$307.6 thousand assuming that the conviction rate and number of cases remains at the FY11 level. The following table provides additional information.

The Administrative Office of the Courts (AOC) reports once the fee is imposed on persons convicted of driving under the influence of intoxicating liquor or drugs, it is collected and deposited at the Magistrate, District and Metro court level. On a monthly basis, those collections are sent to the Administrative Office of the Courts (AOC) where it is deposited into the Crime Lab Fee Agency Fund (Fund 68700), reconciled and sent to Department of Public Safety on a monthly basis. FY 10 total collections for the \$75 DWI Prevention fee were \$651,716 and FY11 total collections were \$588,560. Projected annual collections for the new \$50 fee proposed based on FY11 total collections of \$75 DWI Prevention Fee would be \$392,350 using estimated number of convictions (\$588,560/\$75 = 7,847 estimated convictions; 7,847 x \$50 = \$392,350) or projected collections of \$394,335 using percentage of new fee (\$50/\$75=67%; \$588,560 x 67% = \$394,335). In FY13 it is estimated that half the amount would be collected because many cases filed after July 1, 2012 would not be disposed of until later in the year.

According to the Department of Public Safety, there are fiscal implications to the New Mexico Department of Public Safety from passage of the proposed legislation. On its face, the fund may create revenue on the magnitude of eight hundred fifty thousand dollars (\$850,000.00) annually given the fifty dollar (\$50.00) assessment and the fact that averaged over the last three years roughly seventeen thousand (17,000) DWI cases have been adjudicated per year.

Continuing Appropriations language

This bill creates a new fund and provides for continuing appropriations. The LFC has concerns with including continuing appropriation language in the statutory provisions for newly created funds, as earmarking reduces the ability of the legislature to establish spending priorities.

SIGNIFICANT ISSUES

The courts are not always able to collect all fees assessed and instead allow a defendant to perform community service. Furthermore, the collection of this fee would not take priority over previously established fees.

ADMINISTRATIVE IMPLICATIONS

According to the AOC, it currently collects fines and fees (from all court types), deposits and reconciles a total of 20 agency funds in addition to its 16 operating funds on a monthly basis. This new fee would add an additional process of deposit, reconciliation and distribution to the Department of Public Safety to the numerous monthly reconciliations and distributions by operating transfer to numerous funds, agencies and local governments.

Additionally, the AOC would need to incorporate the new fee into its internal accounting system software, RCS, which is used for receipting all incoming remittances from all courts. The AOC uses RCS to reconcile to the banks for the Magistrate Courts, and to the District and Metro courts deposits on a monthly basis. This change requires programming changes to the software. In addition, all courts must incorporate the new fees into existing case management systems which are now in the process of being upgraded. Until the new Case Management System rollout is complete, there are two different case management systems that must be changed to add the new fee. These consist of the older system, FACTS and the new case management system that is currently being rolled out which is Odyssey. This new fee will also need to be added to the monthly process of reconciliation and distribution to the Department of Public Safety.

The DPS reports that it anticipates that there may be positive performance implications from passage of the proposed legislation in that the Department may be able to purchase public safety equipment on a more expedited basis, thus creating a more nimble response to public safety equipment needs.

TECHNICAL ISSUES

As mentioned in Administrative Issues of the AOC response, adding the new fee to internal receipting and case management software will require significant programming changes.

WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL

Everything remains as is.
