## Synopsis of Bill

Senate Bill 148 appropriates $\$ 500.0$ thousand from the general fund to Native American Veterans' Income Tax Settlement Fund for the purpose of making repayments of income tax collected from Native American Veterans domiciled on tribal lands on entry to the armed forces. The bill was submitted for the Indian Affairs Committee.

## FISCAL IMPLICATIONS

The appropriation of $\$ 500.0$ thousand contained in this bill is a nonrecurring expense to the general fund. Any unexpended or unencumbered balance remaining at the end of fiscal year 2013 shall not revert and will remain in the fund to provide payments in subsequent years. The Veteran Services and Taxation and Revenue Departments are to provide estimates to the Legislature during October of each year on anticipated needs for next fiscal year.
