18	hoc reporting requirements; and
19	WHEREAS, statutory and regulatory reporting requirements
20	of public schools have increased over time; and
21	WHEREAS, while it is recognized that reporting
22	requirements are necessary to ensure accountability, some
23	requirements may be redundant; and
24	WHEREAS, the current economic downturn has necessitated
25	budget restrictions resulting in a reduction of administrative

WHEREAS, reductions in work force at the public education department have decreased the amount of technical assistance and guidance available to public schools; and

WHEREAS, there has been no systematic review of current reporting requirements; and

WHEREAS, efficiency is essential to a successful public education system;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NEW MEXICO that the public education department, in collaboration with appropriate representatives from the New Mexico school boards association, the New Mexico coalition of school administrators, the New Mexico coalition for charter schools and other pertinent stakeholders, be requested to convene a work group to review current reporting requirements to determine which can be repealed or amended without impacting student safety and school academic, cocurricular and extracurricular programs; and

BE IT FURTHER RESOLVED that the work group report its findings and recommendations to the legislative education study committee, the legislative finance committee and the governor no later than November 1, 2012; and

BE IT FURTHER RESOLVED that copies of this memorial be transmitted to the governor, the secretary of public education, .188522.2 - 2 -
