11 RELATING TO MOTOR VEHICLES; PROVIDING FOR THE ISSUANCE OF  
12 SPECIAL REGISTRATION PLATE DECALS TO ACKNOWLEDGE SPECIAL STATUS  
13 OF THE REGISTRANT OR TO ADVOCATE FOR A NONPROFIT PUBLIC PURPOSE  
14 CAUSE; PROVIDING LIMITATIONS; PROVIDING FOR THE COLLECTION OF  
15 FEES AND COSTS; PRESCRIBING PENALTIES; MAKING APPROPRIATIONS.

16  
17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

18 SECTION 1. Section 66-3-15 NMSA 1978 (being Laws 1978,  
19 Chapter 35, Section 35, as amended) is amended to read:

20 "66-3-15. STANDARDIZED AND OTHER SPECIAL REGISTRATION  
21 PLATES--PROCEDURES--FEE.--

22 A. The division shall establish and issue  
23 standardized and other special registration plates, including  
24 motorcycle [~~prestige registration~~] plates, and shall establish  
25 and promulgate procedures for applications for and issuance of

1 special registration plates.

2 B. For a fee of fifteen dollars (\$15.00), which fee  
3 shall be in addition to the regular motor vehicle registration  
4 fees, any owner of a motor vehicle may apply for the issuance  
5 of a standardized or other special registration plate [~~as~~  
6 ~~defined in Subsection A of this section~~], including special  
7 registration plates known as "vanity" plates. No two owners  
8 will be issued identically lettered or numbered plates.

9 C. For a fee of thirty-five dollars (\$35.00) and  
10 any administrative fee charged by the department, not to exceed  
11 fifteen dollars (\$15.00), which fees shall be in addition to  
12 any other registration-related fee, an owner of a motor vehicle  
13 may purchase a special registration decal to be used with the  
14 standardized special registration plate; provided that the  
15 decal fee only applies to purchase from the department and a  
16 public purpose interest group may sell decals for a price  
17 different from this provision.

18 [~~G.~~] D. An owner [~~must~~] or public purpose interest  
19 group shall make a new application and pay a new fee each year  
20 [~~he~~] that the owner or interest group desires to [~~obtain~~] keep  
21 a standardized or other special registration plate [~~however, he~~  
22 ~~will have~~] or decal. The owner of a vanity plate has first  
23 priority on that plate for each subsequent year that [~~he~~] the  
24 owner makes timely and appropriate application and payment.

4 SECTION 2. Section 66-6-23 NMSA 1978 (being Laws 1978,  
5 Chapter 35, Section 358, as amended) is amended to read:

6 "66-6-23. DISPOSITION OF FEES.--

7 A. After the necessary disbursements for refunds  
8 and other purposes have been made, the money remaining in the  
9 motor vehicle suspense fund, except for remittances received  
10 within the previous two months that are unidentified as to  
11 source or disposition, shall be distributed as follows:

12 (1) to each municipality, county or fee agent  
13 operating a motor vehicle field office:

14 (a) an amount equal to six dollars  
15 (\$6.00) per driver's license and five dollars (\$5.00) per  
16 identification card or motor vehicle or motorboat registration  
17 or title transaction performed;

18 (b) for each such agent determined by  
19 the secretary pursuant to Section 66-2-16 NMSA 1978 to have  
20 performed ten thousand or more transactions in the preceding  
21 fiscal year, other than a class A county with a population  
22 exceeding three hundred thousand or a municipality with a  
23 population exceeding three hundred thousand that has been  
24 designated as an agent pursuant to Section 66-2-14.1 NMSA 1978,  
25 an amount equal to one dollar (\$1.00) in addition to the amount

21 (3) to the state road fund:

22 (a) an amount equal to the fees

21 twenty-five cents (\$.25) for each administrative fee collected  
22 by the department or any of its agents other than a county or  
23 municipality operating a motor vehicle field office pursuant to  
24 Subsection A of Section 66-2-16 NMSA 1978; and

4 B. The balance, exclusive of unidentified  
5 remittances, shall be distributed in accordance with Section  
6 66-6-23.1 NMSA 1978.

7 C. If any of the paragraphs, subsections or  
8 sections referred to in Subsection A of this section are  
9 recompiled or otherwise redesignated without a corresponding  
10 change to Subsection A of this section, the reference in  
11 Subsection A of this section shall be construed to be the  
12 recompiled or redesignated paragraph, subsection or section."

13 SECTION 3. A new section of the Motor Vehicle Code is  
14 enacted to read:

15 "[NEW MATERIAL] DECALS FOR STANDARDIZED SPECIAL  
16 REGISTRATION PLATES--DEPARTMENT ADMINISTRATION--REQUIREMENTS--  
17 CURRENT REGISTRATION PLATES--FEES.--

18 A. The department is authorized to issue high-  
19 contrast, machine-readable standardized special registration  
20 plates for motor vehicles, including motorcycles, that have a  
21 space on which to adhere a decal that honors certain New Mexico  
22 citizens or that shows the registrant's support for a worthy  
23 public purpose. Upon the effective date of this section, the  
24 department shall design new standardized special registration  
25 plates; provided that all registration plates extant on motor

1 vehicles on the effective date of this section shall continue  
2 to be lawful registration plates.

3 B. The standardized special registration plates for  
4 motor vehicles, except motorcycles and recreational vehicles,  
5 shall include on the standardized areas:

6 (1) the colors of the state flag, with red  
7 lettering on a yellow background;

8 (2) the phrases "New Mexico USA" and "Land of  
9 Enchantment";

10 (3) a space for applying the self-adhering  
11 special registration decal, centered at the left edge of the  
12 plate, between the top and bottom attachment holes, beginning  
13 one-fourth inch in from the edge of the plate and being four  
14 and one-eighth inches in height and three and one-eighth inches  
15 in width;

16 (4) a vehicle registration number assigned by  
17 the department that consists of five alphanumeric characters  
18 displayed to the right of the special decal area; and

19 (5) a place for validating stickers in the  
20 lower right-hand corner of the registration plate.

21 C. The standardized special registration plates for  
22 motorcycles and recreational vehicles shall be designed by the  
23 department, including the dimensions and other design elements  
24 of the plates.

25 D. Special registration decals, except for the

2 shall be left to the design discretion of the department, in  
3 consultation with the public purpose interest group that  
4 requests the special registration plate decal.

5 E. Special registration decals shall be issued for  
6 the following status categories as requested by a registrant  
7 who demonstrates to the department's satisfaction that the  
8 registrant meets the qualifications for the decal and for whom  
9 fees are waived:

10 (1) members of congress;

11 (2) elected state officials, members of the  
12 legislature, chief clerks of the house of representatives and  
13 the senate and sergeants-at-arms of the house of  
14 representatives and the senate;

15 (3) military honors:

16 (a) medal of honor recipient;

17 (b) prisoner of war and surviving  
18 spouse;

19 (c) fifty percent or more disabled  
20 veteran;

21 (d) national guard member;

22 (e) purple heart recipient; and

23 (f) gold star family; and

24 (4) New Mexico ranger and mounted patrol.

25 F. Special registration decals shall be issued for

9 (1) member of an organized group committed

11 reasonably related to the public safety and welfare;

12 (2) military honors; provided that along with  
13 a military service veteran decal, registrants may receive  
14 veteran-designation stickers to be placed across the top of the  
15 plate, centered above the registration number; and provided,  
16 further, that the veteran-designation stickers shall be  
17 available for purchase from the department at a reasonable  
18 charge to be set by the secretary:

- 19 (a) silver star recipient;  
20 (b) bronze star recipient;  
21 (c) navy cross recipient;  
22 (d) distinguished service cross  
23 recipient;  
24 (e) air force cross recipient;  
25 (f) atomic veteran;

- 2 (h) Vietnam conflict veteran;
- 3 (i) Korean conflict veteran;
- 4 (j) disabled Korean conflict veteran;

- 8 (n) desert storm veteran;
- 9 (o) Iraqi freedom veteran;
- 10 (p) Afghanistan conflict veteran; and

- 14 (4) firefighter or volunteer firefighter;
- 15 (5) retired letter carrier;
- 16 (6) retired national guard member;
- 17 (7) fraternal order of police member;
- 18 (8) civil air patrol member, New Mexico wing;
- 19 (9) retired firefighter;
- 20 (10) retired armed forces member;
- 21 (11) active duty armed forces member;
- 22 (12) search and rescue member;
- 23 (13) retired state police officer;
- 24 (14) emergency medical technician; and
- 25 (15) retired law enforcement officer.

1                   G. Fees collected by the department for the  
2 following standardized special registration plates and status  
3 decals shall be deposited as provided in this section:

4                   (1) military honors with veteran-designation  
5 stickers, to the armed forces veterans license fund;

6                   (2) women veterans, to the armed forces  
7 veterans license fund;

8                   (3) radio station, to the state road fund; and

9                   (4) firefighter or volunteer firefighter, to  
10 the firefighters' survivors fund.

11                   H. Special registration decals shall be provided  
12 for the following public purpose categories and fees collected  
13 by the department after the costs of issuance have been  
14 deducted by the department from the payment of registration  
15 fees shall be distributed as provided:

16                   (1) educational institution booster, to each  
17 educational institution;

18                   (2) children's artwork, to the children's  
19 trust fund;

20                   (3) pet care, to the animal care and facility  
21 fund;

22                   (4) share with wildlife, to the wildlife  
23 program of the game protection fund;

24                   (5) bass fishing, to the bass habitat  
25 management program of the game protection fund;

23 (14) 4-H support, to New Mexico state

3 (16) blood donor, to the department of health  
4 to fund blood donation outreach and education; and

5 (17) any other public purpose the department  
6 approves in accordance with this section and rules adopted to  
7 implement the provisions of this section.

8 I. The department shall provide a standardized  
9 special registration plate to any motor vehicle registrant who  
10 elects to pay the fee provided in Section 66-3-15 NMSA 1978,  
11 which fee is in addition to the regular motor vehicle  
12 registration fee. The registrant may then obtain a status  
13 decal or public purpose decal enumerated in Subsection H of  
14 this section from the department for an additional fee set by  
15 rule of the department but not to exceed fifty dollars  
16 (\$50.00); provided that after administrative expenses have been  
17 deducted from money received by the department for standardized  
18 special registration plates and decals, the department shall  
19 distribute money to funds or persons provided for in this  
20 section through the motor vehicle suspense fund. The  
21 registrant may obtain a public purpose decal from a public  
22 purpose interest group that may charge the decal fee provided  
23 for in the application submitted to the department.

24 J. A public purpose interest group may apply to the  
25 department to have a decal produced by the department that

1 promotes the public purpose interest group and that may be used  
2 by the interest group as a fundraising effort. The interest  
3 group must be a nonprofit organization exempt from taxation  
4 under the provisions of Section 501(c)(3) of the Internal  
5 Revenue Code of 1986, must have been in existence in New Mexico  
6 for at least three years prior to requesting the special  
7 registration decal and must have a statewide focus. In its  
8 application for a decal, the interest group shall provide:

9 (1) a petition in support of the public  
10 purpose decal signed by at least one thousand people to whom  
11 the interest group expects to sell decals within the first  
12 year;

13 (2) additional evidence required by the  
14 department that the interest group will be able to generate a  
15 minimum number of decal sales;

16 (3) information on the amount to be charged  
17 for the decal by the interest group;

18 (4) if the interest group intends to limit  
19 decal sales to members or to persons meeting other  
20 qualifications, a description of those limitations and  
21 qualifications;

22 (5) suggested artwork for the decal; and

23 (6) any other information requested by the  
24 department.

25 K. After an application has been approved, the

1 department shall work with the interest group to finalize the  
2 decal artwork. Upon payment by the interest group of the cost  
3 of at least one thousand decals, the department shall order the  
4 printing and delivery of the decals to the interest group. The  
5 department shall deduct its reasonable administrative costs  
6 from the payment for decals and shall deposit the remainder to  
7 the credit of the state road fund.

8 L. Special registration decals are good for one  
9 year, after which the registrant may purchase the same decal,  
10 another decal or no decal. It is the duty of the registrant to  
11 remove an expired decal or cover it with a current decal. Upon  
12 payment of the standardized special registration fee, which fee  
13 is in addition to the regular registration fee, the registrant  
14 may choose to continue using a standardized special  
15 registration plate even if the registrant removes an expired  
16 decal and does not purchase a new decal, or the registrant may  
17 turn in the standardized special registration plate for a  
18 regular registration plate.

19 M. The department shall promulgate rules to  
20 implement the provisions of this section, which rules shall  
21 include what proof is required by the department to demonstrate  
22 eligibility for a status decal.

23 N. A person who applies an unofficial decal or a  
24 decal for which the person is not qualified to a motor vehicle  
25 standardized special registration plate is guilty of a

1 misdemeanor and shall be fined not to exceed one hundred  
2 dollars (\$100) per day per incident.

3 O. Special registration plates or standardized  
4 special registration plates with logos that have been issued  
5 prior to the effective date of this section shall continue to  
6 be legal registration plates until the holders of the  
7 registration plates return them to the department, but new  
8 applicants for worthy public purpose special registration  
9 plates shall receive standardized special registration plates  
10 with decals.

11 P. This section does not apply to the following:
