SUMMARY

Synopsis of HEC Amendment

The House Education Committee amendment to Senate Finance Committee Substitute for Senate Bill 231 as amended on the Senate Floor specifies that deposits into local financial qualified depositories is mandatory. This restores this requirement to current statute.

Synopsis of SFI Amendment

The Senate Floor Amendments to Senate Finance Committee Substitute for Senate Bill 231:

- Clarifies record keeping procedures for school district investments
- Clarifies that school boards may pay administrative and investment expenses
- Allows Credit unions to be treated exactly the same as banks and other financial institutions.

Synopsis of Original Bill

The Senate Finance Committee Substitute for Senate Bill 231 gives state-chartered charter

schools and school districts with an enrollment of above 3 thousand the same investment options currently reserved to Class A counties. The bill also prohibits local governments from purchasing bonds sold by the Student Loan Marketing Association (Sallie Mae).

District chartered schools would be allowed the investment options afforded all county and municipal treasurers regarding the investment of bond funds.

Lastly the substitute reorders the "equitable distribution" formula used to allocate deposits among financial distributions. It includes credit unions and requires that funds be allocated proportionally to a yet to be developed formula.

SIGNIFICANT ISSUES

Bonds issued by Sallie Mae are rated below investment grade by Standard & Poor's Corporation.

The largest chartered school in the state has 500 enrollees; the bill would apply to 26 districts and no charter schools.

The average size of a school district is 3,500 hundred enrollees. While large school districts such as Albuquerque Public Schools could develop this expertise, the ability of smaller districts to do so is questionable.

Coordinating construction management, bond funds, and the arbitrage requirements of the Tax Reform Act of 1986 is quite complex and time consuming. Small school districts may be hard pressed to take on these duties. Charter schools simply do not have the administrative capacity to perform this task.

The requirement that monies be deposited pro-rata among the districts' financial institutions runs counter to the trustees' fiduciary duty of seeking maximum return consistent with the security of principal. Admittedly, current statute also violates this concept.

TECHNICAL ISSUES

The legal lists of permissible investments enumerated in this bill are outdated and should be reviewed by an interim committee. For example, the list allows the investment of bond funds (for a Class A county) in an <u>equity</u> pool managed by the State investment Council. This would be an imprudent financial practice.

The title of this bill does not refer to the new restriction on Sallie Mae bonds.

Does the bill meet the Legislative Finance Committee tax policy principles?

- 1. Adequacy: Revenue should be adequate to fund needed government services.
- 2. Efficiency: Tax base should be as broad as possible and avoid excess reliance on one tax.
- 3. Equity: Different taxpayers should be treated fairly.
- **4. Simplicity**: Collection should be simple and easily understood.
- 5. Accountability: Preferences should be easy to monitor and evaluate
