### SUMMARY

#### Synopsis of Bill

House Memorial 18 appropriates \$75 thousand to the Indigenous Design and Planning Institute at the University of New Mexico to develop a plan for the preservation of historical and cultural sites and the establishment of a multipurpose center within the Atrisco Land Grant-Merced. This bill includes an emergency clause.

### FISCAL IMPLICATIONS

The bill's appropriation of \$75 thousand is a nonrecurring expense to the General Fund. Any unexpended or unencumbered balance remaining at the end of FY15 shall revert.

### SIGNIFICANT ISSUES

According to the National Park Service, the Atrisco Land Grant-Merced was established in 1598 with the arrival of Don Juan de Onate, and is part of the historic El Camino Real. DCA analysis states that HB 184 has the potential to lay the groundwork to identify and ultimately preserve significant cultural and historical sites on the Atrisco Land Grant-Merced.

Indigenous design and planning is a value-based process that integrates the past, present and future in community development. It is informed by indigenous world-views that value cultural identity, land-tenure and stewardship. It is a process that is invested in consensus building and meaningful collective participation.

**RELATIONSHIP**

House Bill 109 appropriates \$250 thousand dollars to allow the Town of Atrisco Land Grant to contract for the planning, design, and construction of a veterans’ memorial on the grounds of the town’s South Valley multipurpose senior center to commemorate military veterans from the Town of Atrisco Land Grant and Ranchos de Atrisco.

The requests contained in House Memorial 18 and Senate Memorial 33 duplicate the purpose of HB 184, i.e. a study regarding and multipurpose center for the Atrisco Land Grant-merced, but do not carry an appropriation.
