1 interest to provide additional money to enhance or expand vital 2 services to New Mexico's elderly population. This section 3 provides a means by which individuals may donate all or a portion of their income tax refund, through a voluntary 4 check-off designation, to provide supplemental funding through 5 the non-metro area agency on aging to senior service providers 6 7 throughout the state. It is the intent of the legislature that 8 this program of income tax refund check-off is supplemental to 9 any other funding and is in no way intended to take the place of the funding that would otherwise be appropriated for this 10 11 purpose.

B. Except as otherwise provided in Subsection D of this section, an individual whose state income tax liability after application of allowable credits and tax rebates in a year is lower than the amount of money held by the department to the credit of such individual for that tax year may designate a portion of the income tax refund due to the individual to be paid to the north central New Mexico economic development district as the non-metro area agency on aging for the provision of supplemental senior services throughout the state, including senior services provided through the city of Albuquerque/Bernalillo county area agency on aging, the Indian area agency on aging and the Navajo area agency on aging. In the case of a joint return, both individuals must make the designation.
