16	SECTION 1. Section 27-1-16 NMSA 1978 (being Laws 2013,
17	Chapter 44, Section 1) is amended to read:
18	"27-1-16. BRAIN INJURY SERVICES FUND CREATED
19	A. There is created in the state treasury the
20	"brain injury services fund". The fund shall be invested in
21	accordance with the provisions of Section 6-10-10 NMSA 1978,
22	and all income earned on the fund shall be credited to the
23	fund.
24	B. The brain injury services fund shall be used to
25	institute and maintain a statewide brain injury services

C. The human services department shall adopt all rules, regulations and policies necessary to administer a statewide brain injury services program. The human services department shall coordinate with and seek advice from the brain injury advisory council to ensure that the statewide brain injury services program is appropriate for persons with [traumatic] brain injuries.

D. All money credited to the brain injury services fund shall be appropriated to the human services department for the purpose of carrying out the provisions of this section and shall not revert to the general fund.

E. Disbursements from the brain injury services fund shall be made upon warrant drawn by the secretary of finance and administration pursuant to vouchers signed by the secretary of human services.

F. For the purposes of this section, "brain injury": (1) means an injury to the brain of traumatic

<u>or acquired origin, including an open or closed head injury</u> <u>caused by:</u>

<u>(a) an insult to the brain from an</u> outside physical force; <u>(b) anoxia;</u>
