C. Thirty days prior to the cancellation of the instruction permit, driver's license or provisional license, the department shall provide written notice to the person that the instruction permit, driver's license or provisional license will be canceled if the person's social security number or new application, pursuant to Section 66-5-9 NMSA 1978, is not submitted within thirty days.

D. Upon cancellation, the department shall notify the person in writing of the cancellation of that person's instruction permit, driver's license or provisional license. Within twenty days of receiving notice of cancellation, a person may request that the department rescind the order of cancellation and afford the person an opportunity to show that the person has submitted the person's social security number and proof of the person's identity and proof of New Mexico residency pursuant to Section 66-5-9 NMSA 1978.

E. Within twenty days upon receipt of a request to rescind the order of cancellation, the department shall provide the person who made the request with an opportunity to show that the person has submitted that person's social security number and proof of the person's identity and proof of New Mexico residency, pursuant to Section 66-5-9 NMSA 1978, in the county in which the person resides unless the department and .195702.1
