17	SECTION 1. Section 61-14E-7 NMSA 1978 (being Laws 1983,
18	Chapter 317, Section 7, as amended) is amended to read:

20	A. It is unlawful, unless licensed by the

nurse-midwife may perform ultrasound procedures limited to a focused imaging target. A registered nurse or certified nursemidwife shall not perform diagnostic ultrasound.

C. The requirement of a medical imaging license shall also not apply to a student who is enrolled in and attending a required individual education program of a school or college of medicine, osteopathy, chiropractic, podiatry, dentistry or dental hygiene to apply radiation to humans under the supervision of a licensed practitioner or under the direct supervision of a licensed medical imaging professional or radiation therapist.

D. Notwithstanding any other provision of the Medical Imaging and Radiation Therapy Health and Safety Act, the requirement of a license shall not apply to a student completing clinical requirements of an approved education program working under the supervision of a licensed practitioner or under the direct supervision of a medical imaging professional or radiation therapist licensed in the practice for which the student is seeking licensure.

E. The department shall adopt rules and regulations for the education and licensure of advanced medical imaging professionals.

F. The department may require students in medical imaging and radiation therapy educational programs to register with the department while enrolled in an approved education

A registered nurse or a certified nursemidwife shall not perform ionizing procedures, including 3 radiography, radiation therapy, nuclear medicine or a non-4 5 ionizing magnetic resonance procedure, unless licensed by the department as a medical imaging professional. Nothing in the 6 7 Medical Imaging and Radiation Therapy Health and Safety Act shall affect the authority of a health care professional 8 9 licensed pursuant to Chapter 24 or Chapter 61 NMSA 1978 to order or use images resulting from ionizing or non-ionizing 10 procedures in accordance with the licensed health care 11 12 professional's scope of practice.

H. Notwithstanding any other provision of the Medical Imaging and Radiation Therapy Health and Safety Act, the requirement of a license shall not apply to a doctor of oriental medicine certified in expanded practice who performs diagnostic musculoskeletal ultrasound or musculoskeletal ultrasound procedure guidance."
