18	SECTION 1. Section 24-10B-1 NMSA 1978 (being Laws 1983,
19	Chapter 190, Section 1) is amended to read:
20	"24-10B-1. SHORT TITLE[This act] Chapter 24, Article
21	<u>10B NMSA 1978</u> may be cited as the "Emergency Medical Services
22	Act"."
23	SECTION 2. A new section of the Emergency Medical
24	Services Act is enacted to read:
25	"[<u>NEW MATERIAL</u>] CRIMINAL HISTORY BACKGROUND CHECKS

The department may obtain a criminal history Α. record of an applicant or licensee from the department of public safety, the federal bureau of investigation or any other law enforcement agency or organization that meets the criminal history standards set by the federal bureau of investigation or the department of public safety.

7 Β. Arrest record information received from the department of public safety and the federal bureau of 8 9 investigation shall be privileged and shall not be disclosed to persons not directly involved in the decision affecting the 10 applicant or licensee. The department shall comply with 11 12 applicable confidentiality requirements of the department of public safety and the federal bureau of investigation regarding 13 the dissemination of criminal history background check 14 information. Electronic live fingerprint scans may be used 15 when conducting criminal history background checks. 16

C. An applicant or licensee whose license is denied, suspended or revoked or who is otherwise disciplined based on information obtained in a criminal history background check shall be entitled to appeal the decision under the provisions of the Uniform Licensing Act.

D. The secretary shall adopt and promulgate rules relating to criminal history background checks for applicants These rules shall include: and licensees.

(5) providing for submission of an applicant's or licensee's fingerprint cards to the federal bureau of investigation to conduct a national criminal history background check and to the department of public safety to conduct a state criminal history background check, identifying what information obtained from a criminal history background check may form the basis of denial, suspension or revocation of a license or any other disciplinary action; and

(6) the frequency with which the department shall require a criminal history background check.
