16	SECTION 1. Section 77-1-20 NMSA 1978 (being Laws 1993,

18	"77-1-20. STERILIZATION AGREEMENT AND STERILIZATION
19	DEPOSIT REQUIRED
20	A. [No] An animal shall not be released from an
21	animal shelter to an adopting person unless a sterilization
22	agreement has been signed and a sterilization deposit has been
23	paid [as provided in] <u>pursuant to</u> Subsections C and D of this
24	section; provided that an animal rescue organization exempt
25	from federal taxation pursuant to Section 501(c)(3) of the

<u>Internal Revenue Code of 1986, as amended or renumbered, is not</u>
 <u>required to pay a sterilization deposit otherwise required by</u>
 <u>this section</u>.

B. In addition to any adoption fee charged, a sterilization deposit of at least twenty-five dollars (\$25.00) shall be imposed on the adoption of each animal from an animal shelter.

8 C. Animals less than six months of age shall be
9 released only upon payment of the adoption fee and a
10 sterilization deposit and after the adopting person has signed
11 an agreement stating [he] that the adopting person will have
12 the adopted animal sterilized when it is no older than six
13 months of age.

D. Adult animals over the age of six months shall be released only upon payment of the adoption fee and a sterilization deposit and after the adopting person has signed an agreement stating [he] that the adopting person will have the animal sterilized within thirty days of the date of adoption.

E. The sterilization deposit shall be reimbursed only upon presentation of a receipt from a veterinarian that the adopted animal has been sterilized.

F. An unsterilized animal reclaimed by its owner shall be released without being sterilized upon payment of the twenty-five dollars (\$25.00) for the sterilization deposit and .195679.1
