for liver transplants, pre- and post-liver transplant services and the prevention and treatment of liver disease at such a facility;

(3) a fiscal analysis of the funding required to establish a liver institute, including funding to support establishment and operations of the liver institute before it develops the capacity to bill private and public third-party payers for its services;

9 (4) an identification of institutional
10 infrastructures in the state that may support a liver institute
11 in Gallup and the financial feasibility of establishing
12 cooperative relationships between these institutions and a
13 liver institute in Gallup; and

(5) an analysis of the capital expenditures necessary to establish a liver institute in Gallup, including an identification of any existing capital infrastructure that may be adapted for use by a liver institute.

B. The legislative finance committee staff shall provide a written report and an oral presentation of its findings to the legislative finance committee and the interim legislative health and human services committee by November 1, 2015.

SECTION 2. APPROPRIATION.--Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the legislative finance committee for expenditure in fiscal year
