that person knows or has reason to know that the obscene medium depicts [any] <u>a</u> prohibited sexual act [or simulation of such act] and if that person knows or has reason to know that one or more of the participants in that act is a child under eighteen years of age. A person who violates the provisions of this subsection is guilty of a third degree felony.

C. It is unlawful for a person to intentionally cause or permit a child under eighteen years of age to engage in [any] <u>a</u> prohibited sexual act [or simulation of such an act] if that person knows, has reason to know or intends that the act may be recorded in [any] <u>an</u> obscene visual or print medium or performed publicly. A person who violates the provisions of this subsection is guilty of a third degree felony, unless the child is under the age of thirteen, in which event the person is guilty of a second degree felony.

D. It is unlawful for a person to intentionally manufacture [any] an obscene visual or print medium depicting [any] a prohibited sexual act [or simulation of such an act] if one or more of the participants in that act is a child under eighteen years of age. A person who violates the provisions of this subsection is guilty of a second degree felony.

E. It is unlawful for a person to intentionally manufacture [any] <u>an</u> obscene visual or print medium depicting [any] <u>a</u> prohibited sexual act [or simulation of such an act] if that person knows or has reason to know that the obscene medium

depicts a prohibited sexual act [or simulation of such an act] and if that person knows or has reason to know that a real child under eighteen years of age, who is not a participant, is depicted as a participant in that act. A person who violates the provisions of this subsection is guilty of a fourth degree felony.

F. It is unlawful for a person to intentionally distribute [any] an obscene visual or print medium depicting [any] a prohibited sexual act [or simulation of such an act] if that person knows or has reason to know that the obscene medium depicts a prohibited sexual act [or simulation of such an act] and if that person knows or has reason to know that a real child under eighteen years of age, who is not a participant, is depicted as a participant in that act. A person who violates the provisions of this subsection is guilty of a third degree felony.

G. The penalties provided for in this section shall be in addition to those set out in Section 30-9-11 NMSA 1978.

H. For the purposes of this section, the possession, distribution or manufacture of each separate depiction of a child under eighteen years of age engaged in a prohibited sexual act contained on an item of visual or print medium shall be considered a distinct act and shall be charged as an individual criminal offense pursuant to the relevant subsection of this section."
