AN ACT

RELATING TO STATE AGENCIES; PROVIDING NEW SUNSET DATES FOR
CERTAIN AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 9-15-51 NMSA 1978 (being Laws 2003,
Chapter 166, Section 4 and Laws 2003, Chapter 170, Section 4,
as amended) is amended to read:

"9-15-51. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
The office of military base planning and support and the
military base planning commission are terminated on July 1,
[2015] 2021 pursuant to the provisions of the Sunset Act. The
office and the commission shall continue to operate according
to the provisions of Sections 9-15-48 through 9-15-51 NMSA 1978
until July 1, [2016] 2022. Effective July 1, [2016] 2022,
Sections 9-15-48 through 9-15-51 NMSA 1978 are repealed."

1 **SECTION 2.** Section 61-2-18 NMSA 1978 (being Laws 1979,
2 Chapter 12, Section 3, as amended) is amended to read:

4 The board of optometry is terminated on July 1, [~~2015~~] 2023
5 pursuant to the Sunset Act. The board shall continue to
6 operate according to the provisions of the Optometry Act until
7 July 1, [~~2016~~] 2024. Effective July 1, [~~2016~~] 2024, the
8 Optometry Act is repealed."

9 **SECTION 3.** Section 61-4-17 NMSA 1978 (being Laws 1979,

15 Physician Practice Act until July 1, [~~2016~~] 2022. Effective
16 July 1, [~~2016~~] 2022, the Chiropractic Physician Practice Act is
17 repealed."

18 **SECTION 4.** Section 61-5A-30 NMSA 1978 (being Laws 1994,
19 Chapter 55, Section 42, as amended) is amended to read:

20 "61-5A-30. TERMINATION OF AGENCY LIFE--DELAYED
21 REPEAL.--The New Mexico board of dental health care is
22 terminated on July 1, [~~2015~~] 2023 pursuant to the Sunset Act.
23 The board shall continue to operate according to the provisions
24 of the Dental Health Care Act and the Impaired Dentists and
25 Dental Hygienists Act until July 1, [~~2016~~] 2024. Effective

10 [~~2016~~] 2022. Effective July 1, [~~2016~~] 2022, the Nutrition and
11 Dietetics Practice Act is repealed."

12 SECTION 6. Section 61-8-17 NMSA 1978 (being Laws 1979,
13 Chapter 385, Section 2, as amended) is amended to read:

14 "61-8-17. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
15 The board of podiatry is terminated on July 1, [~~2015~~] 2023
16 pursuant to the Sunset Act. The board shall continue to
17 operate according to the provisions of the Podiatry Act until
18 July 1, [~~2016~~] 2024. Effective July 1, [~~2016~~] 2024, the
19 Podiatry Act is repealed."

20 SECTION 7. Section 61-9-19 NMSA 1978 (being Laws 1978,
21 Chapter 188, Section 2, as amended) is amended to read:

22 "61-9-19. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--
23 The New Mexico state board of psychologist examiners is
24 terminated on July 1, [~~2015~~] 2021 pursuant to the Sunset Act.
25 The board shall continue to operate according to the provisions

5 Chapter 266, Section 2, as amended) is amended to read:

6 "61-11-29. TERMINATION OF AGENCY LIFE--DELAYED
7 REPEAL.--The board of pharmacy is terminated on July 1, [~~2015~~]
8 2023 pursuant to the Sunset Act. The board shall continue to
9 operate according to the provisions of the Pharmacy Act until
10 July 1, [~~2016~~] 2024. Effective July 1, [~~2016~~] 2024, the
11 Pharmacy Act is repealed."

12 SECTION 9. Section 61-14B-25 NMSA 1978 (being Laws 1996,
13 Chapter 57, Section 25, as amended) is amended to read:

14 "61-14B-25. TERMINATION OF AGENCY LIFE--DELAYED
15 REPEAL.--The speech-language pathology, audiology and hearing
16 aid dispensing practices board is terminated on July 1, [~~2015~~]
17 2021 pursuant to the Sunset Act. The board shall continue to
18 operate according to the provisions of the Speech-Language
19 Pathology, Audiology and Hearing Aid Dispensing Practices Act
20 until July 1, [~~2016~~] 2022. Effective July 1, [~~2016~~] 2022, the
21 Speech-Language Pathology, Audiology and Hearing Aid Dispensing
22 Practices Act is repealed."

23 SECTION 10. Section 61-31-25 NMSA 1978 (being Laws 1989,
24 Chapter 51, Section 27, as amended) is amended to read:

25 "61-31-25. TERMINATION OF AGENCY LIFE--DELAYED
