When a sex offender who is registered or required to register is employed, begins a vocation or is enrolled as a student at an institution of higher education in New Mexico, the sex offender shall disclose the sex offender's status as a sex offender in writing to the county sheriff for the county in which the institution of higher education is located, the law enforcement entity responsible for the institution of higher education and the registrar for the institution of higher education no later than five business days after beginning employment, beginning a vocation or enrolling at the institution of higher education. A sex offender who willfully or knowingly fails to comply with the registration or verification requirements set forth in this section after a first or subsequent conviction for a violation pursuant to this section is guilty of a third degree felony and shall be sentenced pursuant to the provisions of Section 31-18-15 NMSA 1978. A. A court shall provide a sex offender convicted in that court with written notice of [his] the sex offender's duty to register pursuant to the provisions of the Sex Offender Registration and Notification Act. The written notice shall be included in judgment and sentence forms provided to the sex offender. The written notice shall inform the sex offender that [he] the sex offender is required to:

SECTION 3. [NEW MATERIAL] INTERNET CRIMES AGAINST CHILDREN FUND--CREATED.--The "internet crimes against children fund" is created in the state treasury. The fund shall consist of appropriations, gifts, grants and donations to the fund, income from investment of the fund, money that is credited to the fund pursuant to Section 29-11A-4 NMSA 1978 and money otherwise accruing to the fund. Money in the fund shall not revert to any other fund at the end of a fiscal year. The attorney general shall administer the fund, and money in the fund is appropriated to the attorney general for costs related to the investigation of internet crimes against children. Payments from the internet crimes against children fund shall be made upon vouchers issued and signed by the attorney general or the attorney general's designee upon warrants drawn by the secretary of finance and administration.

SECTION 4. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 2015.
