15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. Section 10-16D-3 NMSA 1978 (being Laws 2010,
17	Chapter 34, Section 3, as amended) is amended to read:
18	"10-16D-3. SUNSHINE PORTALDEPARTMENT DUTIES
19	A. The department, with the department of finance
20	and administration, shall develop, operate and maintain a
21	single internet web site that is free, user-friendly,
22	searchable and accessible to the public, known as the "sunshine
23	portal", to host the state's financial information for the
24	purpose of governmental transparency and accountability to
25	taxpayers.

No later than October 1, 2010, the department 2 shall create the architecture and the information exchange process for the collection and electronic publication of the 3 state's financial information. 4 C. No later than July 1, 2011, the sunshine portal 5 shall be available for public access and include updated 6 7 information as required by Subsection D of this section. 8 D. The sunshine portal shall provide, at a minimum, access to the following information: 9 the state's cash balances by account or 10 (1) fund; 11 12 (2) a monthly summary of the state's 13 investment accounts: 14 (3) annual operating budgets for each state agency with monthly expenditures by category; 15 (4) contracts that a state agency enters into 16 for the lease, sale or development of state land and state 17 contracts that have a total contract price of more than twenty 18 19 thousand dollars (\$20,000) [naming the recipient of the 20 contract, the purpose of the contract and the amounts expended].
