I request that the following be funded:

• to the department of environment

### EUNICE SEWER & WATER INFRA IMPROVE

five hundred thousand dollars (\$500,000) to plan, design and construct water and sewer system improvements in Eunice in Lea county

#### HOBBS ROCKWIND GOLF COURSE EFFLUENT PIPELINES

five hundred twenty-two thousand dollars (\$522,000) to plan, design and construct pipelines for transmission of reclaimed effluent water to the Rockwind golf course in Hobbs in Lea county

### HOBBS SEWER SYS & TRUNK LINE IMPROVE

six hundred fifty thousand dollars (\$650,000) to design and construct improvements to the sewer system, including replacing the major sewer trunk line and manholes, in Hobbs in Lea county

### HOBBS WASTEWATER TREATMENT SYS IMPROVE/DIGESTER

three hundred thousand dollars (\$300,000) to plan and design wastewater system improvements, including an aerobic digester, at the wastewater treatment facility in Hobbs in Lea county
