one million dollars (\$1,000,000) to plan, design, improve, construct, landscape, fence and repair the facilities, grounds and infrastructure, including purchase and installation of security cameras, fire protection and alarm systems, information technology and related equipment and improvements, at the central New Mexico correctional facility in Los Lunas in Valencia county

- to the corrections department

**CORRECTIONS DEPT OFFENDER MGMT SYS PH 1**

five million five hundred thousand dollars (\$5,500,000) to plan, design and implement phase 1 of an offender management system for the corrections department in Santa Fe in Santa Fe county

- to the cultural affairs department

**PALACE OF THE GOVERNORS IMPROVE**

one million five hundred thousand dollars (\$1,500,000) to plan, design, repair, restore, construct and equip improvements at the palace of the governors in Santa Fe in Santa Fe county

- to the Cumbres and Toltec scenic railroad commission

**CTSRRC LAND & BLDG FOR VISITOR GATEWAY CENTER**

one hundred six thousand two hundred fifty dollars (\$106,250) to purchase land and to plan, design and construct a visitor gateway center for the Cumbres and Toltec scenic railroad commission in Chama in Rio Arriba county

one hundred twenty-five thousand dollars (\$125,000) to acquire easements and rights of way for water system improvements for the Southside mutual domestic water association in Aztec in San Juan county

### SOUTHSIDE MDWA WATER SYS IMPROVE

sixty-five thousand dollars (\$65,000) to plan, design and construct water system improvements for the Southside mutual domestic water association in Aztec in San Juan county

### BLOOMFIELD REGIONAL WATER SUPPLY IMPROVE

two hundred fifty thousand dollars (\$250,000) to plan, design and construct regional water system and supply improvements and a San Juan river diversion for Bloomfield in San Juan county

### BLOOMFIELD WATER STORAGE POND

eight hundred fifty thousand dollars (\$850,000) to plan, design and construct a recycled water storage pond in Bloomfield in San Juan county

### FARMINGTON WATER SYSTEM IMPROVE

six million dollars (\$6,000,000) to plan, design and construct water system improvements in Farmington in San Juan county

four million dollars (\$4,000,000) to plan, design, construct, equip and furnish a fire station in the north Foothills area of Farmington in San Juan county

### FARMINGTON TOTAH RIVER PK & NATIVE AMER MARKET

three million five hundred thousand dollars (\$3,500,000) to plan, design and construct the Totah River park and Native American marketplace in Farmington in San Juan county

### FARMINGTON VILLA VIEW STORM WATER DETENTION POND

two million one hundred thousand dollars (\$2,100,000) to purchase land and to plan, design and construct storm drainage improvements, a storm water detention pond and infrastructure near Villa View drive in Farmington in San Juan county

one million five hundred thousand dollars (\$1,500,000) to construct the east Aztec arterial route in Aztec in San Juan county

one million nine hundred sixty-five thousand dollars (\$1,965,000) to design, construct, equip and furnish an office building and warehouse for the San Juan soil and water conservation district in San Juan county
