AN ACT

RELATING TO STATE AGENCIES; PROVIDING NEW SUNSET DATES FOR  
CERTAIN AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 9-15-51 NMSA 1978 (being Laws 2003,  
Chapter 166, Section 4 and Laws 2003, Chapter 170, Section 4,  
as amended) is amended to read:

"9-15-51. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
The office of military base planning and support and the  
military base planning commission are terminated on  
July 1, 2021 pursuant to the provisions of the Sunset Act.  
The office and the commission shall continue to operate  
according to the provisions of Sections 9-15-48 through  
9-15-51 NMSA 1978 until July 1, 2022. Effective  
July 1, 2022, Sections 9-15-48 through 9-15-51 NMSA 1978 are  
repealed."

SECTION 2. Section 61-2-18 NMSA 1978 (being Laws 1979,  
Chapter 12, Section 3, as amended) is amended to read:

"61-2-18. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
The board of optometry is terminated on July 1, 2023 pursuant  
to the Sunset Act. The board shall continue to operate  
according to the provisions of the Optometry Act until  
July 1, 2024. Effective July 1, 2024, the Optometry Act is  
repealed."

1 SECTION 3. Section 61-4-17 NMSA 1978 (being Laws 1979,  
2 Chapter 77, Section 2, as amended) is amended to read:

3 "61-4-17. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
4 The chiropractic board is terminated on July 1, 2021 pursuant  
5 to the Sunset Act. The board shall continue to operate  
6 according to the provisions of the Chiropractic Physician  
7 Practice Act until July 1, 2022. Effective July 1, 2022, the  
8 Chiropractic Physician Practice Act is repealed."

9 SECTION 4. Section 61-5A-30 NMSA 1978 (being Laws 1994,  
10 Chapter 55, Section 42, as amended) is amended to read:

11 "61-5A-30. TERMINATION OF AGENCY LIFE--DELAYED  
12 REPEAL.--The New Mexico board of dental health care is  
13 terminated on July 1, 2023 pursuant to the Sunset Act. The  
14 board shall continue to operate according to the provisions  
15 of the Dental Health Care Act and the Impaired Dentists and  
16 Dental Hygienists Act until July 1, 2024. Effective  
17 July 1, 2024, the Dental Health Care Act and the Impaired  
18 Dentists and Dental Hygienists Act are repealed."

19 SECTION 5. Section 61-7A-15 NMSA 1978 (being Laws 1989,  
20 Chapter 387, Section 15, as amended) is amended to read:

21 "61-7A-15. TERMINATION OF AGENCY LIFE--DELAYED  
22 REPEAL.--The nutrition and dietetics practice board is  
23 terminated on July 1, 2021 pursuant to the Sunset Act. The  
24 board shall continue to operate according to the provisions  
25 of the Nutrition and Dietetics Practice Act until

1 July 1, 2022. Effective July 1, 2022, the Nutrition and  
2 Dietetics Practice Act is repealed."

3 SECTION 6. Section 61-8-17 NMSA 1978 (being Laws 1979,  
4 Chapter 385, Section 2, as amended) is amended to read:

5 "61-8-17. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
6 The board of podiatry is terminated on July 1, 2023 pursuant  
7 to the Sunset Act. The board shall continue to operate  
8 according to the provisions of the Podiatry Act until  
9 July 1, 2024. Effective July 1, 2024, the Podiatry Act is  
10 repealed."

11 SECTION 7. Section 61-9-19 NMSA 1978 (being Laws 1978,  
12 Chapter 188, Section 2, as amended) is amended to read:

13 "61-9-19. TERMINATION OF AGENCY LIFE--DELAYED REPEAL.--  
14 The New Mexico state board of psychologist examiners is  
15 terminated on July 1, 2021 pursuant to the Sunset Act. The  
16 board shall continue to operate according to the provisions  
17 of the Professional Psychologist Act until July 1, 2022.  
18 Effective July 1, 2022, the Professional Psychologist Act is  
19 repealed."

20 SECTION 8. Section 61-9A-30 NMSA 1978 (being Laws 1993,  
21 Chapter 49, Section 30, as amended) is amended to read:

22 "61-9A-30. TERMINATION OF AGENCY LIFE--DELAYED  
23 REPEAL.--The counseling and therapy practice board is  
24 terminated on July 1, 2021 pursuant to the provisions of the  
25 Sunset Act. The board shall continue to operate according to

1 the provisions of the Counseling and Therapy Practice Act  
2 until July 1, 2022. Effective July 1, 2022, the Counseling  
3 and Therapy Practice Act is repealed."

4 SECTION 9. Section 61-10-22 NMSA 1978 (being Laws 1979,  
5 Chapter 36, Section 2, as amended) is amended to read:

6 "61-10-22. TERMINATION OF AGENCY LIFE--DELAYED  
7 REPEAL.--The board of osteopathic medical examiners is  
8 terminated on July 1, 2021 pursuant to the Sunset Act. The  
9 board shall continue to operate according to the provisions  
10 of Chapter 61, Article 10 NMSA 1978 until July 1, 2022.  
11 Effective July 1, 2022, Chapter 61, Article 10 NMSA 1978 is  
12 repealed."

13 SECTION 10. Section 61-11-29 NMSA 1978 (being Laws  
14 1979, Chapter 266, Section 2, as amended) is amended to read:

15 "61-11-29. TERMINATION OF AGENCY LIFE--DELAYED  
16 REPEAL.--The board of pharmacy is terminated on July 1, 2023  
17 pursuant to the Sunset Act. The board shall continue to  
18 operate according to the provisions of the Pharmacy Act until  
19 July 1, 2024. Effective July 1, 2024, the Pharmacy Act is  
20 repealed."

21 SECTION 11. Section 61-12A-24 NMSA 1978 (being Laws  
22 1996, Chapter 55, Section 24, as amended by Laws 2005,  
23 Chapter 199, Section 12 and by Laws 2005, Chapter 208,  
24 Section 7) is amended to read:

25 "61-12A-24. TERMINATION OF AGENCY LIFE--DELAYED

1 REPEAL.--The board of examiners for occupational therapy is  
2 terminated on July 1, 2021 pursuant to the provisions of the  
3 Sunset Act. The board shall continue to operate according to  
4 the provisions of the Occupational Therapy Act until  
5 July 1, 2022. Effective July 1, 2022, the Occupational  
6 Therapy Act is repealed."

7 SECTION 12. Section 61-12B-16 NMSA 1978 (being Laws  
8 1984, Chapter 103, Section 17, as amended) is amended to  
9 read:

10 "61-12B-16. TERMINATION OF BOARD--DELAYED REPEAL.--The  
11 advisory board of respiratory care practitioners is  
12 terminated on July 1, 2021 pursuant to the Sunset Act. The  
13 board shall continue to operate according to the provisions  
14 of the Respiratory Care Act until July 1, 2022. Effective  
15 July 1, 2022, the Respiratory Care Act is repealed."

16 SECTION 13. Section 61-12C-28 NMSA 1978 (being Laws  
17 1993, Chapter 173, Section 21, as amended) is amended to  
18 read:

19 "61-12C-28. TERMINATION OF AGENCY LIFE--DELAYED  
20 REPEAL.--The massage therapy board is terminated on  
21 July 1, 2021 pursuant to the provisions of the Sunset Act.  
22 The board shall continue to operate according to the  
23 provisions of the Massage Therapy Practice Act until  
24 July 1, 2022. Effective July 1, 2022, Chapter 61, Article  
25 12C NMSA 1978 is repealed."

1 SECTION 14. Section 61-12D-17 NMSA 1978 (being Laws  
2 1997, Chapter 89, Section 17, as amended) is amended to read:

3 "61-12D-17. TERMINATION OF AGENCY LIFE--DELAYED  
4 REPEAL.--The physical therapy board is terminated on  
5 July 1, 2021 pursuant to the Sunset Act. The board shall  
6 continue to operate according to the provisions of the  
7 Physical Therapy Act until July 1, 2022. Effective  
8 July 1, 2022, the Physical Therapy Act is repealed."

9 SECTION 15. Section 61-14B-25 NMSA 1978 (being Laws  
10 1996, Chapter 57, Section 25, as amended) is amended to read:

11 "61-14B-25. TERMINATION OF AGENCY LIFE--DELAYED  
12 REPEAL.--The speech-language pathology, audiology and hearing  
13 aid dispensing practices board is terminated on July 1, 2021  
14 pursuant to the Sunset Act. The board shall continue to  
15 operate according to the provisions of the Speech-Language  
16 Pathology, Audiology and Hearing Aid Dispensing Practices Act  
17 until July 1, 2022. Effective July 1, 2022, the  
18 Speech-Language Pathology, Audiology and Hearing Aid  
19 Dispensing Practices Act is repealed."

20 SECTION 16. Section 61-14D-19 NMSA 1978 (being Laws  
21 1993, Chapter 325, Section 19, as amended) is amended to  
22 read:

23 "61-14D-19. TERMINATION OF AGENCY LIFE--DELAYED  
24 REPEAL.--The athletic trainer practice board is terminated on  
25 July 1, 2021 pursuant to the provisions of the Sunset Act.

1 The board shall continue to operate according to the  
2 provisions of the Athletic Trainer Practice Act until  
3 July 1, 2022. Effective July 1, 2022, Chapter 61, Article  
4 14D NMSA 1978 is repealed."

5 SECTION 17. Section 61-31-25 NMSA 1978 (being Laws  
6 1989, Chapter 51, Section 27, as amended) is amended to read:

7 "61-31-25. TERMINATION OF AGENCY LIFE--DELAYED  
8 REPEAL.--The board of social work examiners is terminated on  
9 July 1, 2021 pursuant to the Sunset Act. The board shall  
10 continue to operate according to the provisions of the Social  
11 Work Practice Act until July 1, 2022. Effective July 1, 2022,  
12 the Social Work Practice Act is repealed." \_\_\_\_\_
