Honorable President Pro Tempore Papen and Members of the Senate:

A narrative explaining the action I have taken on all three pieces of capital-related legislation can be found in the message attached to House Bill 219.

I have this day SIGNED SENATE FINANCE COMMITTEE SUBSTITUTE FOR SENATE BILL 172, as amended, with emergency clause, enacted by the Fifty-Second Legislature, Second Session, 2016, except the following part or parts, item or items, which I have vetoed pursuant to Article IV, Section 22 of the Constitution of the State of New Mexico:

On page 3, I have vetoed lines 20 through 25, and on page 4, I have vetoed all of lines 1 and 2.

On page 16, I have vetoed all of lines 21 through 25, and on page 17, I have vetoed all of lines 1 through 3.

On page 20, I have vetoed all of lines 24 and 25, and on page 21, I have vetoed all of lines 1 through 5.

On page 21, I have vetoed all of lines 16 through 23.

On page 26, I have vetoed all of lines 3 through 15.

On page 27, I have vetoed all of lines 2 through 12.

On page 27, I have vetoed all of lines 13 through 23.

On page 27, on line 25, I have vetoed the words “CHANGE AGENCY- -“, and on page 28, on line 5, after the word “county”, I have vetoed the remainder of the line, and on line 6, I have vetoed the words “division and”.

On page 28, on line 9, I have vetoed the words “CHANGE AGENCY- -“, and on line 14, after the word “county”, I have vetoed the remainder of the line, and on line 15, I have vetoed through the word “and”.

On page 29, I have vetoed all of lines 23 through 25, and on page 30, I have vetoed all of lines 1 through 8.

On page 34, I have vetoed all of lines 17 through 23.

On page 39, I have vetoed line 25, and on page 40, I have vetoed all of lines 1 through 10.

On page 43, on line 25, I have vetoed the words “WELCOME SIGNAGE,”, and on page 44, on line 7, I have vetoed the words “and install welcome signage”.
