16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	SECTION 1. Section 66-3-16 NMSA 1978 (being Laws 1978,
18	Chapter 35, Section 36, as amended) is amended to read:
19	"66-3-16. DISTINCTIVE REGISTRATION PLATESPERSONS WITH
20	SIGNIFICANT MOBILITY LIMITATIONPARKING [PLACARD] PLACARDS
21	A. The division shall issue distinctive
22	registration plates for use on motor vehicles and motorcycles
23	owned <u>or leased</u> by a person with a significant mobility
24	limitation who requests a distinctive registration plate and
25	who proves satisfactorily to the division that the person

[meets the standard provided in Subsection J of this section] is a person with a significant mobility limitation.

B. The division shall issue a distinctive parking
placard to an organization that owns or leases a motor vehicle
that primarily transports a person or persons with a
significant mobility limitation and that requests a distinctive
parking placard. The organization, if qualified, may obtain a
distinctive parking placard for each vehicle used to transport
persons with a significant mobility limitation.

<u>C.</u> No fee in addition to the regular registration fee, if any, applicable to the motor vehicle or motorcycle shall be collected for issuance of distinctive registration plates or parking placards pursuant to this section.

[B.] D. No person shall falsely claim to have a significant mobility limitation so as to be eligible to be issued a distinctive registration plate or a parking placard pursuant to this section when the person does not in fact have a significant mobility limitation. Upon notice and opportunity to be heard, the division may revoke and demand return of any placard when:

(1) it was issued in error or with false information;

(2) the person receiving the placard is no longer eligible; [or]

 $[G_{\cdot}]$ <u>E</u>. Upon written application to the division 4 5 accompanied by a medical statement by a licensed physician or a physician assistant, advanced practice registered nurse or 6 7 certified nurse-midwife working within that person's scope of 8 practice attesting to the permanent significant mobility 9 limitation, a resident of the state who has a significant mobility limitation, as provided in this section, may apply for 10 and be issued no more than two parking placards for display 11 12 upon a motor vehicle registered to the person or motor vehicle owned by another person who is transporting the person with a 13 significant mobility limitation. The physician or the 14 physician assistant, advanced practice registered nurse or 15 certified nurse-midwife working within that person's scope of 16 practice shall provide the division all information and records 17 necessary to issue a permanent parking placard. Once approved 18 for use of a permanent parking placard, a person with a 19 20 significant mobility limitation shall not be required to furnish further medical information. 21

F. To obtain a distinctive parking placard pursuant to this section, an organization shall submit, on a form approved by the division, a signed statement by an authorized officer of the organization affirming that the registered .202545.1

1 vehicle is owned or leased by the organization and that the 2 vehicle will be primarily used to transport a person or persons with a significant mobility limitation. 3 [D.] G. A parking placard issued pursuant to this 4 5 section shall expire four years from the date it was issued. [E.] H. The division shall issue two-sided 6 7 hanger-style parking placards with the following 8 characteristics: 9 (1) a picture of the international symbol of 10 access; a hologram to make duplication difficult; (2) 11 12 (3) an imprinted expiration date; and for a placard issued to: 13 (4) (a) a person with a significant mobility 14 limitation, a full-face photograph of the holder on the inside 15 of the placard covered by a flap; or 16 (b) an organization, the number of the 17 registration plate issued to the vehicle that is registered or 18 leased to the organization on which the placard will be used. 19 20 $[F_{\cdot}]$ <u>I</u>. The division shall consult with the governor's commission on disability for continued issuance and 21 format of the placard. 22 [G.] J. [H.] K. Upon written application to the division accompanied by a medical statement from a licensed physician or a physician assistant, advanced practice registered nurse or certified nurse-midwife working within that person's scope of practice attesting to a temporary significant mobility limitation, a person may be issued a temporary placard for no more than one year. The physician or the physician assistant, advanced practice registered nurse or certified nurse-midwife working within that person's scope of practice shall provide the division all information and records necessary to issue a temporary placard.

[1.] L. Registration plates or parking placards issued to a person with a significant mobility limitation by another state or foreign jurisdiction shall be honored until the motor vehicle or motorcycle is registered or the parking placard holder establishes residency in this state.

[J.] M. A "person with a significant mobility limitation" means a person who:

cannot walk one hundred feet without (1)stopping to rest;

(2) cannot walk without the use of a brace, cane or crutch or without assistance from another person, a prosthetic device, a wheelchair or other assistive device;
