15	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
16	SECTION 1. A new section of Chapter 47, Article 1 NMSA
17	1978 is enacted to read:
18	"[<u>NEW MATERIAL</u>] USE OF SCRIVENER'S-ERROR AFFIDAVITS
19	A. As used in this section, "scrivener's-error
20	affidavit" means an affidavit to correct a drafting or clerical
21	error in:
22	(1) a legal description, such as the omission
23	of one or more words;
24	(2) the name of a subdivision;
25	(3) the recording information for a plat;

A scrivener's-error affidavit shall be executed 10 Β. by only the following: 11 12 (1) for an error on a deed or other legal document prepared in conjunction with the closing of a 13 14 transaction affecting the title to real property: the licensed attorney who prepared (a) 15 the original instrument; or 16 the employee of the title insurer or 17 (b) title insurance agent who completed the form of the original 18 instrument, if still employed by that insurer or agent and if 19 20 licensed under the New Mexico Title Insurance Law; for an error on a mortgage or deed of (2) 21 trust: 22 (a) a licensed attorney who represents 23 the mortgagee or beneficiary named in the form of the original 24 25 instrument; or .202627.1 - 2 -

A scrivener's-error affidavit shall: 15 state that the affiant has actual (1)16 knowledge of and is competent to testify to the facts in the 17 affidavit and contain an acknowledgment that the affiant is 18 testifying under the penalty of perjury; 19 20 (2) be sworn to and acknowledged by the affiant before a person authorized to administer an oath under 21 New Mexico law; 22 conspicuously identify in its title that (3) 23 it is a "scrivener's affidavit" or "scrivener's-error 24 affidavit"; and 25 .202627.1 - 3 -
