one hundred eighty thousand dollars (\$180,000) to purchase and install a communications tower and for repairs at the Ojito tower site on New Mexico highway 537 for the Jicarilla Apache Nation in Rio Arriba county

NAGEEZI CHP ELECTRIC POWER LINE EXTENSION

two hundred eighty-nine thousand six hundred seventy-seven dollars (\$289,677) to construct the Kinnadiz and Pillow Crest electrical powerline extension project in the Nageezi chapter of the Navajo Nation in San Juan county

NASCHITTI CHP LAUNDROMAT ADDITION

five hundred fifty-seven thousand dollars (\$557,000) to plan, design and construct an addition to the laundromat in the Naschitti chapter of the Navajo Nation in San Juan county
