I request that the following be funded:

one hundred thousand dollars (\$100,000) to plan, design and construct the ruins footprint at the Coronado historic site in Sandoval county

- to the public education department

ASK ACADEMY CHARTER SCHL REN & IMPROVE

one hundred sixty-seven thousand dollars (\$167,000) to plan, design, construct, renovate, furnish and equip buildings and grounds, including a track, ball courts and the purchase and installation of tables, sheds, shade structures, fencing and information technology with related equipment, furniture and infrastructure, for the Ask Academy charter school in Rio Rancho in Sandoval county

INDEPENDENCE HIGH SCHL MAIN ENTRY

seventy thousand dollars (\$70,000) to plan, design and construct improvements to the entry at Independence high school in the Rio Rancho public school district in Sandoval county

one hundred forty thousand dollars (\$140,000) to plan, design and construct main entry improvements to V. Sue Cleveland high school in the Rio Rancho public school district in Sandoval county

four hundred thousand dollars (\$400,000) to plan, design and construct an arroyo diversion structure and open space area on Sheriff's Posse road for the southern Sandoval county arroyo flood control authority in Bernalillo in Sandoval county

four hundred eighty-six thousand dollars (\$486,000) to purchase and equip vehicles for the sheriff's department in Sandoval county

fifty-five thousand eight hundred forty-six dollars (\$55,846) to purchase emergency medical equipment for the fire and rescue department in Rio Rancho in Sandoval county

seven hundred fifty thousand dollars (\$750,000) to purchase and equip a ladder truck for the fire and rescue department in Rio Rancho in Sandoval county

forty thousand dollars (\$40,000) to plan, design and construct improvements to baseball fields at the north complex in Rio Rancho in Sandoval county

four hundred thousand dollars (\$400,000) to purchase and equip vehicles for the police department in Rio Rancho in Sandoval county

RIO RANCHO SUNSET LITTLE LEAGUE SHADE STRUCT

forty thousand dollars (\$40,000) to plan, design, purchase, construct and install shade structures and scoreboards at Sunset little league facilities in Rio Rancho in Sandoval county

two million six hundred thousand dollars (\$2,600,000) to acquire rights of way and to design and construct paseo del Volcan, also known as New Mexico highway 347, in Sandoval and Bernalillo counties

PASEO DEL VOLCAN RIGHTS OF WAY SANDOVAL CO

one million dollars (\$1,000,000) to purchase rights of way for paseo del Volcan from Unser boulevard to the Bernalillo-Sandoval county line

LINCOLN AVE ROW & CONSTRUCT - RIO RANCHO

one million dollars (\$1,000,000) to acquire rights of way for and to plan, design and construct a Lincoln avenue extension from Adams lane to Paseo del Volcan in Rio Rancho in Sandoval county

SOUTHERN BLVD CONSTRUCT MAY/GOLF - RIO RANCHO

five million dollars (\$5,000,000) to plan, design and construct improvements to Southern boulevard from May circle to Golf Course road in Rio Rancho in Sandoval county

VERANDA RD IMPROVE - RIO RANCHO

eight hundred twenty-five thousand dollars (\$825,000) to plan, design and construct road, sidewalk and accessibility improvements to Veranda road in Rio Rancho in Sandoval county
