one hundred thousand dollars (\$100,000) to purchase and install music and dance equipment and information technology, including related equipment, furniture and infrastructure, for Tierra Adentro charter school in Albuquerque in Bernalillo county

six hundred thousand dollars (\$600,000) to plan, design and construct a sewer line and lift station in Milan in Cibola county
