WHEREAS, the ability to speak both English and Spanish can provide financial rewards, such as bilingual pay differential, in the workforce; and

WHEREAS, pursuant to Article 12, Section 8 of the constitution of New Mexico, the legislature has been required to provide for the training of teachers so that they may become proficient in both the English and Spanish languages; and

WHEREAS, in 2013, seventy-three percent of Hispanics age five years and older spoke Spanish at home, according to United States census bureau statistics; and

WHEREAS, as of 2015, nearly forty-eight percent of the greater Albuquerque metropolitan area is of Hispanic origin; and

WHEREAS, according to the United States census bureau, seventeen and five-tenths percent of the Albuquerque workingage population speaks both English and Spanish, which places Albuquerque in the top twenty-five of all United States bilingual metropolitan areas; and

WHEREAS, New Mexico is uniquely positioned to supply employees to the workforce who speak Spanish as well as English; and

WHEREAS, central New Mexico community college is in the forefront of this effort with a major bilingual education initiative to promote Spanish as a workforce development .202873.1
