15	A. The division, in consultation with the
16	committee, shall develop instructions for those agencies
17	required to submit performance-based program budget requests.
18	The instructions shall be sent to the agencies on or before
19	June 15 of each year and shall be in addition to any other
20	forms required by Section 6-3-18 NMSA 1978. The instructions
21	shall require that performance-based program budget requests
22	contain the following:
23	(1) a summary of each approved program,
24	including a justification for the program;
25	(2) for each approved program, an evaluation

 The evaluation shall be developed as prescribed in the budget
 instructions;

5 outcomes, baseline data, performance measures and historic and

8 on an approved program during either the present or any of the
9 immediately preceding two fiscal years, any responses that the
10 agency may have to the audit and any actions that the agency
11 has taken as a result of the audit; [and]

12 (5) the results of the program inventory 13 pursuant to Section 5 of this 2017 act and a summary of how the 14 agency has prioritized evidence-based, research-based or 15 promising sub-programs within its performance-based program 16 budget request; and

[(5)] <u>(6)</u> any other information that the division believes may be useful to the division or the legislature in developing a budget for the agency.

B. On or before September 1 of each year, each agency shall submit a performance-based program budget request to the division and the committee in the form and manner prescribed in the budget instructions. Budget requests submitted pursuant to this section shall be in lieu of those required by Section 6-3-19 NMSA 1978."

disincentives for agency performance and implementation of evidence-based, research-based or promising sub-programs. Incentives or disincentives may apply to all or part of an agency and may apply to any or all of an agency's approved programs.

C. Pursuant to Section 6-3-7 NMSA 1978, the division shall prescribe forms and approve operating budgets for agencies funded by performance-based program budgets; 8 however, the division shall not take any action that hinders an agency from operating under a performance-based appropriation 10 or that is otherwise inconsistent with the purposes of the 12 Accountability in Government Act. Notwithstanding the provisions of Sections 6-3-23 through 6-3-25 NMSA 1978, and 14 absent specific authorization in the general appropriation act or other act of the legislature, no funds may be transferred either into or out of a performance-based program budget. 16

Each agency shall develop, in consultation with D. the division, a plan for monitoring and reviewing the agency's programs to ensure that performance data are maintained and supported by agency records."

SECTION 5. A new section of the Accountability in Government Act is enacted to read:

"[NEW MATERIAL] PROGRAM INVENTORY .-- The division and the committee shall approve a list of programs to inventory on or before June 15 of each year. The division shall send to each .205216.1
