In school districts having hazardous walking 6 С. 7 conditions as determined by the local school board and 8 confirmed by the state transportation director, students of any 9 grade may be transported a lesser distance than that provided in Subsection B of this section. General standards for 10 determining hazardous walking conditions shall be established 11 12 by the state transportation division of the department [of education] with the approval of the [state board] department, 13 14 but the standards shall be flexibly and not rigidly applied by the local school board and the state transportation director to 15 prevent accidents and help ensure student safety. 16
